

To the Honorable County Court of the State of Oregon, for
Umatilla County:

WE, THE UNDERSIGNED, your petitioners, who are residents and householders in
Umatilla County, Oregon, and who reside in the vicinity of the hereinafter described
route for a County road, respectfully petition your honorable body to cause to be laid
out, located and established, a County road in said County and State, commencing,

running and terminating as follows, to-wit: *Commencing at a point in the NW 1/4 Sec 31 T3N R6E
E 1/2 NW 1/4 N 62° 42' E 42.60 chains distant from the SW corner of said NW 1/4 Sec 31 thence Northerly
through NE 1/4 Sec 31 thence southerly through NW 1/4 Sec 20 and SE 1/4 Sec 31 T3N R6E S 1/2 NW 1/4 thence in
a southerly direction on the most practicable route through Secs 6-7-8-18-12 N 6 3/4 E 1/2 NW 1/4 thence southerly
easterly crossing Meacham creek on the most practicable route to the east side of creek to the west line of the
O.R. & N. Co. rightway in the NE 1/4 Sec 19 thence in a southerly direction along the west line of said right
away as near as practicable through Secs 19-30 & 31 T2N R6E S 1/2 NW 1/4 thence in a southeasterly direction
on the most practicable route to the SE corner Sec 5 in T1N R6E S 1/2 NW 1/4 thence south 12 1/4 chains
thence easterly to the west line of O.R. & N. Co. rightway thence southerly along west line of said
rightway 34 1/2 chains thence in a southerly and easterly direction through NW 1/4 Sec 7 Secs 16-21-27
and NE 1/4 Sec 24 to south side of North Fork creek thence northerly along the south side of North Fork
creek following as near the south bank of said creek as practicable for a road and crossing said
creek to the north side S 70° E 39 rods distant from the NW corner of the NE 1/4 Sec 35 thence northerly
on the most practicable route through NE 1/4 Sec 35 Secs 26 and 25 to a point 100 ft
North of the SE corner of the NE 1/4 Sec 25 T1N R6E S 1/2 NW 1/4*

Said road to be **40** feet wide.
