**WHEREAS**, the Umatilla County Board of Commissioners may, under authority of ORS 368.201 to 368.221, order county roads that have been used and traveled by the public for ten (10) years or more to be surveyed and recorded, and

**WHEREAS**, the Umatilla County Board of Commissioners ordered the survey of Helix Cemetery Road, County Road No. 953, lying in the north ½ of Section 11, Township 4 North, Range 33 E.W.M., south of and within the City of Helix, and

**WHEREAS**, the Notice of Hearing was posted and all owners of abutting property affected by the legalization procedure were served copies of the Notice of Hearing, and

**WHEREAS**, the Umatilla County Board of Commissioners on June 1, 2005, held a public hearing and finding that it would be in the public interest to legalize the road:

**THEREFORE IT IS NOW ORDERED** that the road be legalized as follows:

A strip of land of variable width for road and utility installation purposes located in Section 11, Township 4 North, Range 33 E.W.M., the centerline of which is described as follows:

Beginning at a 5/8" iron pin assigned Engineer's Station "Helcem" 10+00.00 P.O.T. which bears S49°37'13"E, 3867.33 feet from a brass-capped monument marking the northwest corner of said Section 11; thence N02°56'25"W, 1308.96 feet to a 5/8" iron pin and Engineer's Station "Helcem" 23+08.96 P.I.; thence N03°33'12"W, 281.91 feet to Engineer's Station 25+90.87 P.I.; thence N02°34'58"W, 986.71 feet to a point in the center of State Highway No. 335 assigned Engineer's Station "Helcem" 35+77.58 P.O.T. which bears S02°34'58"E, 127.78 feet from a railroad spike marking the North ¼ Corner of Section 11 and the terminus of this description. The width of the above described road is 60 feet (30 feet on each side of centerline) from Station 10+00.00 to Station 23+08.96 and 40 feet (20 feet on each side of centerline) from Station 23+08.96 to Station 35+77.58.

EXCEPTING THEREFROM any portion lying within the Helix Cemetery and that portion lying within the right-of-way limits of State Highway No. 335.

Bearings and distances are NAD '83('91) grid. The plat of the above described road is recorded as Survey No. 05-60-C in the Umatilla County Surveyor's Office.
