Field Notes of Road No 505

I met J M Ferguson, W D Hanford and J S Gurdane, Viewers, at the Court House and administered the usual oath to each, on August 25th, 1899, as per order of the County Court for Umatilla County, Oregon, at the regular term for July, 1899, July the 16th, 1899. We called to our assistance Geary Kimbrell and J N Kirby as Chaimmen and Dennis O Bryon as marker, who were duly qualified by me as such. Commencing at the S.E. Corner Section 28, in T. 3 N. R. 33 E. N. M. Set post 4 inches square, 4 feet long 28 1/2 feet N. W. from initial point, marked R. 505; dug pits 24x24x12 inches E & S of post and built mound of Earth four feet wide at base and 18 inches high around post:
