RELINQUISHMENT OF TITLE

KNOW ALL MEN BY THESE PRESENTS, That the STATE OF OREGON, by and through its DEPARTMENT OF TRANSPORTATION, Highway Division, hereinafter called "State", hereby relinquishes and conveys unto UMATILLA COUNTY, a political subdivision of the State of Oregon, hereinafter called "County", its right, title and interest in and to the following described property, only so long as used for public road purposes, to wit:

PARCEL 1

A parcel of land lying in the SW $\frac{1}{4}$ of Section 11, Township 2 North, Range 32 East, W.M., Umatilla County, Oregon, being designated as Parcel 2 and conveyed by that certain Final Judgment dated May 24, 1967, and filed in the Circuit Court of the State of Oregon for the County of Umatilla, wherein the State of Oregon, by and through its State Highway Commission, was the plaintiff and Gladys A. Goad et al were the defendants and bearing Case No. 9313.

PARCEL 2

A parcel of land lying in the S $\frac{1}{2}$ of Section 11, Township 2 North, Range 32 East, W.M., Umatilla County, Oregon, being designated as Parcel 2 and conveyed by that certain Final Judgment dated April 24, 1968, and filed in the Circuit Court of the State of Oregon for the County of Umatilla, wherein the State of Oregon, by and through its State Highway Commission, was the plaintiff and Harold G. Rees et al were the defendants and bearing Case No. 9451.

This relinquishment is made, executed and delivered pursuant to ORS 271.330 and to complete a portion of that certain agreement dated March 8, 1966, entered into by the parties herein, the property herein relinquished being no longer needed or required for state highway, park or scenic purposes.

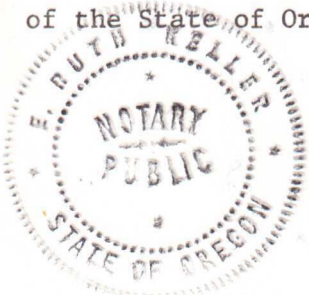
