In the Matter of Locating, Establishing, Altering, Widening, Straightening and Changing a County Road from Embysk's ranch in Missouri Gulch to where Missouri Gulch connects with De Spain Gulch.

RESOLUTION

County Road No. 888

TO ALL PERSONS WHOM IT MAY CONCERN:

WHEREAS, it is deemed advisable that a County Road or Highway be located, established, altered, widened, straightened and changed from Embysk's ranch in section 6, Township 3 North, Range 32 East, W.M. down Missouri Gulch in the most feasible route to where Missouri Gulch connects with De Spain Gulch.

and that said Road or Highway be located, established, altered, widened, straightened and changed by resolution of the County Court of Umatilla County, State of Oregon.

AND WHEREAS, this being a regular term of the Umatilla County Court and the said Court being now in regular session, sitting for the transaction of County Business with all members of said Court present.

NOW, THEREFORE, BE IT RESOLVED by the County Court of Umatilla County, State of Oregon, sitting at the regular monthly term for the month of June 1929, in the County Court Room of the Court House, in Pendleton, Umatilla County, State of Oregon, for the transaction of County business, that it is and is hereby declared to be the intention of the said County Court to locate, establish, alter, widen, straighten and change a road or highway on and over a route as follows:

BE IT RESOLVED that the proposed County Road No. 888

shall commence, run and terminate as follows, to-wit: Beginning at a point 1255 feet South and 2000 feet East of the North west corner of section 6, Township 3 North, Range 32 East W.M. thence down Missouri Gulch in the most feasible route to a point 385 feet North and 2080 feet East of the center of Section 30 Township 4 North, Range 31 East, W.M.

The right of way or roadway to be a strip of land 60 feet wide, being 30 feet on each side of the above described line.

Be IT FURTHER RESOLVED that a public necessity for the road or highway is hereby declared to exist for the following reasons, to-wit: that it places a road above and away from the Missouri Gulch creek bed and furnishes an all the year outlet.

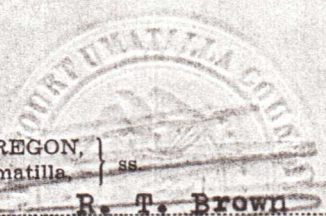
BE IT FURTHER RESOLVED that the above entitled matter be heard at the regular August term for the year 1929, of said County Court at the County Court House at Pendleton, in the County of Umatilla, State of Oregon. on the 7th day of August, at 11 o'clock, A.M.

BE IT FURTHER RESOLVED that true copies of this Resolution, properly certified to as such by the County Clerk, be posted by Walter M. Ransom as follows, to-wit: That a copy be posted upon the bulletin board in the west corridor of the County Court House in Pendleton, Oregon, said Court House being the place where the County Court is held; That three copies be posted in three public places in the vicinity of the said proposed road; And that this Resolution be duly entered in the Commissioners Journal.
