R E S O L U T I O N  
Indian Service roads

WHEREAS, the United States Government, by and through the Bureau of Indian Affairs of the Department of Interior, hereinafter referred to as BIA, proposed to relinquish and transfer to Umatilla County, all its rights to and responsibility for certain roads;

WHEREAS, it appears that the BIA has completed construction and improvements so that said roads conform to the minimum requirements for County Roads as set forth in ORS-368.415 and related statutes and has filed certified maps thereof with the County, and

WHEREAS, it appears that BIA has obtained agreements with all owners of real estate adjoining said roads consenting to the establishment of said Indian Service roads for the use of the public, and

WHEREAS, it is the opinion of this Court that the acceptance of and establishment as County roads of the hereinafter described Indian Service roads will improve the network of County roads in the Umatilla County and will benefit the public, and

WHEREAS, this Court being fully advised in the premises and under authority of ORS Chapter 368.555, to accept from BIA, under the authority granted the BIA in CFR-161.20 and as found in the Federal register Vol. 33, No. 251, effective Dec. 27, 1968, to establish as County roads, and now

IT IS HEREBY ORDERED that the following Indian Service roads, hereinafter listed and/or attached hereto, be and the same is hereby declared as County Roads.

- Viz: P-1, Sumac Canyon Road and the Mc. Kay Creek (Grade) Road; P-3, Spring-hollow Road; and the Umbarger Road; P-4, Curl-Kanine Road; P-5, Presbyterian Church (Patawa Place) Road; P-6, Sheoship Road; P-7, Best Road; P-9, Cayuse (Abraham) River Road; P-12, Mc. Kay (to P-1) Creek Road; P-16, North Mission-Cayuse (Mann) Road; and N. Mission-Cayuse (Kirkpatrick) Road; P-17, Cayuse River (George) Road; P-18, Barnhart (So. Theater) Road; P-19, Tubbs-Cayuse Road; P-20, Tutuilla Church Road (alters 40' to 50' R/W.); P-20, St. Andrew's School Road; P-22, Lloyde Road; P-24, Hanna Road and Best Road; P-28, Crawford Road; P-30, Maloney Road and Hall Road. The roads hereinabove listed contain in total length 54.1 miles; More particularly described of the hereinabove said listed roads is attached hereto and made a part of.

IT IS FURTHER ORDERED that this order be entered in the Journal of this Court.
