That we the undersigned, being the owners of all the deeded lands over which it is desired to establish a County road, in Umatilla County, State of Oregon, described as follows:— a certain Strip of land 40 feet wide, to be used as a right of way for a right of way for a public road, the center line of which is described as follows. Beginning at the (14) one quarter, Section Corner between section (1) one and (12) twelve, in Township (1) one, South, of range, 32, thirty two E. W. M. thence along the section line between sections (1) one, and (12) twelve, in Township and range, as aforesaid, N. 89° 26' W. (427) four hundred and twenty seven feet N. 80° 03' W. (215) two hundred and fifteen feet S. 72° 07' W (114) one hundred and fourteen feet S. 37° 23' W (350) three hundred and fifty feet N. 5° 45' W (400) four hundred feet S. 57° 45' W. (169) one hundred and sixty nine feet N. 89° 26' W. (1336) thirteen hundred and thirty six feet along aforesaid section line to the corner of section (1) one, (2) two (11) Eleven (12) twelve, Township (1) one South, of range, 32, thirty two E. W. M.
