post 4 ft. long 4 ins. sq. N 4° E 30 ft. dist. from the initial point, marked R No. 568,
dug pits 18x18x12 ins. N & W from post and raised mound 18 ins. high 4 ft. base around
post; thence South 20 ft. thence East 1320 feet; thence North 20 feet; thence East 1320
feet; thence South 20 feet; thence East 792 feet; thence North 40 feet; set post 4 ft-
long 4 ins. sq. 24 ins. in the ground S 45° E 36 ft. dist. Marked R T No. 568, dug pits
18x18x12 ins. S and E of Post and raised mound 18 ins. 4 ft. base; thence West 2112 feet
thence South 20 feet to place of beginning.

4 ft- long 4 ins. sq. 24 ins in the ground S 45° W 45 lbs dist. from Initial point marked
R no. 569, dug pits 18x18x12 ins. S and W from post, and raised mound of earth 18 ins.
high 4 ft. base; thence West 80 chs. set post 4 ft. long 4 ins. sq 24 ins in the ground
marked R T No. 569, dug pits 18x18x12 ins. N & S of post, raised mound 18 ins. high 4 ft.
base; thence South 30 feet; thence east 40 chs; thence South 10 feet; thence East 40 chs.
thence North 40 ft. to place of beginning.
