upon said matter, and,


IT APPEARING that due and lawful advertisement of
the final hearings have been given by the posting of three
certified copies of the Order of this Court declaring its in-
tention to vacate such road, in three public places and in
the vicinity of said road which is proposed to be vacated and
also by the posting of a certified copy of such order on the
Bulletin board at the West door of the County Court House in
Pendleton, Oregon, being the place of holding the County Court,
and all for at least thirty days prior to the date of hearing,
and,


IT FURTHER APPEARING that due proof of the posting
of said Order is on file herein, and that such affidavit is be-
fore the Court, and it appearing that no objections have been
made or filed to such proposed vacation and that said road so
proposed to be vacated is not useful as part of the general
road system of Umatilla County and that such road will not be
in the future useful as part of the general road system and
is not of sufficient public benefit to warrant the same being
maintained by the County.

IT IS THEREFORE CONSIDERED, ORDERED AND ADJUDGED that such portion of said County Road is useless and dangerous to maintain and is of no value to individuals or to the general public and is useless as part of the road system of Umatilla County, and that the public will be benefitted by its vacation and the same is hereby vacated.

BE IT RESOLVED by the County Court of the State of Oregon for Umatilla County, sitting for the transaction of County business, that proceedings to vacate that portions of County roads No. 409 and 467, described as follows:

Beginning at a point on the Section line 30 feet west of the Section corner common to Sections 11, 12, 13 and 14, Township 1 North, Range 32 East W.M. thence West along said Section line 1733 feet; thence north 30 feet thence West on line 30 feet North of and parallel to said Section line 875 feet to a point 30 feet north of Quarter Section Corner common to Sections 11 and 14, thence South 10 feet, thence West on line 20 feet North of and parallel to said Section line, 200 feet; thence South 25 degrees 00' West, 117 feet; thence North 70 degrees 00' West, 173 feet, to a point on the Section line common to Sections 11 and 14; thence West along said Section line approximately 2330 feet to a point on the east right of way line of the Oregon-Washington Highway, County Road No. 832, all in Township 1 North, Range 32 East, W.M. in Umatilla County, Oregon.

shall be undertaken; that said road is useless as a part of the general road system, is burdensome and dangerous to maintain and that the people and public will be benefitted by the vacation of that part of said road above described.

IT IS ORDERED that the Clerk of this Court in its behalf, shall notify the County roadmaster, of Umatilla County, Oregon, of the proceeding instituted by the foregoing Resolution and said County Roadmaster is directed to examine the road mentioned in said Resolution and make a report in writing on the same and on the matter mentioned in the Resolution.
