RESOLUTION

County Road No. 915

TO ALL PERSONS WHOM IT MAY CONCERN:

WHEREAS, it is deemed advisable that a County Road or Highway be located, established, altered, widened, straightened and changed for Highway purposes being 60 feet wide and lying in the SW¹/₄ of Section 10, and the N¹/₂ of Section 15 Township 2, N. R. 32 E. W. M.

and that said Road or Highway be located, established, altered, widened, straightened and changed by resolution of the County Court of Umatilla County, State of Oregon.

AND WHEREAS, this being a regular term of the Umatilla County Court and the said Court being now in regular session, sitting for the transaction of County Business with all members of said Court present.

NOW, THEREFORE, BE IT RESOLVED by the County Court of Umatilla County, State of Oregon, sitting at the regular monthly term for the month of December 1938, in the County Court Room of the Court House, in Pendleton, Umatilla County, State of Oregon, for the transaction of County business, that it is and is hereby declared to be the intention of the said County Court to locate, establish, alter, widen, straighten and change a road or highway on and over a route as follows:

BE IT RESOLVED that the proposed County Road No 915 Known as the Tutuilla Road

shall commence, run and terminate as follows, to-wit:

Beginning at a point 570 feet East of and 130.2 feet North of the Section corner common to Sections 9, 10, 15 and 16, thence around a 52.1 foot radius curve to the left the long cord of which bears S. 37° 46' East a distance of 79.5 feet, thence S. 81° 28' E. 121.0 feet thence around a 63.7 foot radius curve to the right the long cord of which bears S 51° 03' E. a distance of 67.6 thence S 20° 39' E. a distance of 293.9 feet, thence around a 62.1 foot radius curve to the left the long cord of which bears S. 66° 01' North East a distance of 100.9 feet thence N 68° 36' E. a distance of 266.5 feet, thence around an 818.5 radius curve to the right the long cord of which bears N. 75° 35' E. a distance of 199.2 feet, thence N. 82° 33' E. a distance of 384.7 feet, thence around a 318.3 foot radius curve to the right the long cord of which bears 79° 05' E. a distance of 204.1 feet, thence S 60° 43' E. a distance of 119.9 feet thence around a 286.5 radius curve to the left the long cord of which bears S. 71° 27' E. a distance of 107.3 feet, thence S. 82° 11' E. a distance of 336.5 feet, thence around a 57.3 foot radius curve to the right the long

The right of way or roadway to be a strip of land 60 feet wide, being 30 feet wide on each side of the above described line.

BE IT FURTHER RESOLVED that a public necessity for the said road or highway is hereby declared to exist for the following reasons, to-wit:

BE IT FURTHER RESOLVED that true copies of this Resolution, properly certified to as such by the County Clerk, be posted by County Surveyor as follows, to-wit: That a copy be posted upon the bulletin board in the west corridor of the County Court House, in Pendleton, Oregon, said Court House being the place where the County Court is held; That three copies be posted in three public places in the vicinity of the said proposed road; And that this Resolution be duly entered in the Commissioners Journal.
