read the first time on April 3, 1918, and having been pub-  
licly read the second time on April 4, 1918,

And said Board of County Road Viewers find that  
said road is used but little, and therefore, recommend that  
said road be vacated,

And the Court finds that said road is not now of  
public utility and is not needed as a part of the general  
road system of Umatilla County,

IT IS HEREBY ORDERED that said report of the Board  
of County Road Viewers be approved and that the same be re-  
corded in the records of plats and field notes of Umatilla  
County,

And that the owners of the land over and through  
which said road crosses be, and they are permitted to close  
said road to public travel.

REPORT OF BOARD OF COUNTY ROAD VIEWERS.

In the matter of viewing County Road proposed to be vacated commencing at the intersection of Despañ Gulch road, in sections 3 and 4, T. 3 N., R. 31 E., W. M.

To the Honorable County Court of the State of Oregon, for Umatilla County.

We, the undersigned Board of County Road Viewers, heretofore instructed to view said road, beg to submit the following report.

Pursuant to your order we met at Pendleton, Oregon on the first day of April 1918. The viewers each having been duly qualified we viewed said road as specified in our order.

We find that the said road has been open to traffic but is very little used at present, that it is laid out on a route having very steep grades, that on account of its situation and location will never be needed as a part of the general road system and as a local road it is not needed at the present time.

We therefore recommend that the aforesaid road be vacated.
