And it appearing to the Court that the said Viewers met at the time and place specified in the order of the Court and that they duly qualified in said behalf before entering upon the discharge of their duties in this behalf, and the matter coming on at this time for final hearing, IT IS THEREFORE ORDERED AND ADJUDGED that upon payment by the petitioners of the sum of \$20.00, damages awarded to the said Peter Deardorf, by the said viewers, that the said road shall be opened for public use and as a public highway..and to vacate that road lying between the N.W. Cor of the S.W.1/4 of the N.W.1/4, and N.E. Cor of S.W.1/4, and between N.E.cor.of S.W.1/4 and th

N.E. Cor of S.E.1/4 of section 27 Tp.4.N.R.36.E.W.M.  
In the matter of proposed County Road No.539 :  
Commencing at the end of the present County :  
road, about 60 rods south of the Northwest Cor:  
ner of Section 29 Tp 5 North, Range 37 E.W.M. :  
thence running in an easterly direction along:  
the north side of the North fork of the Walla: ROAD No. 539.  
Walla river as near the bluff as practicable :  
to the School house situated about the N.W. :  
Corner of the S.E.1/4 of the N.E.1/4 of said :  
section 29; thence continuing easterly along :  
the old travelled road to the Northwest cor- :  
ner of the N.W.1/4 of Section 27 Tp.5.N.r.37.:

On this day this matter coming on for hearing, and it duly appearing to this Court at this time that the report of the viewers heretofore appointed herein has been filed herein, and recommended the opening of said road, and that complaint has been filed herein by Sarah J. Kelley claiming damages for injury by the opening of said road, and that viewers should be appointed to assess the damages, if any, to said party by reason of the opening of said road,

IT IS NOW THEREFORE HEREBY ORDERED that H.L. Frazier, A.M. Elam and D.J. Phelps, three disinterested householders of the said Umatilla County, Oregon, be, and they are hereby appointed viewers to proceed and view said road through the premises of said complainant and assess and determine how much less valuable such premises of said complainant would be rendered by the opening of said road, and they shall report the same in writing to this Court at its next regular term; and that said viewers so appointed shall Meet at Millon Ore on the 20th day of August 1902, for said purpose.

In the matter of County Road No.540, Commencing :  
at a point 21 rods west of the S.E. Corner of sec, :  
6 in Tp.5.N.R.33.E.W.M. thence running northeasterly :  
along the east side of ravine to a point 1700 feet : ROAD No. 540  
North of said S.E. Corner, Sec, 6; and to vacate that present County :  
present County road, intervening between the said S.E. :  
Corner of sec 6, and the intersection of proposed :  
County Road to-wit: 1700 feet north of the corner of :  
sec 5-6-7 and 8 in Tp.5 N.R.33 E.W.M. :

Now on this day comes the report of viewers F.A. Gordon, Kenneth McRae, and Wm. Mills, heretofore appointed at the May term of this Court to view out and report upon the location of the above road as a county road, for final hearing, the same having been read at a previous day of this Court, to-wit: the July term, 1902, and the said viewers having reported favorably and recommended the establishing of the same as a County road, and the field notes and plat of survey being duly on file and certified to by the surveyor appointed to survey the same, and there being no remonstrance or claim for damages on file against said road,

IT IS THEREFORE ORDERED by the Court that the report of said viewers be accepted, and that the said road be established as a county road in accordance with the report of said viewers, and that the field notes and plat of survey thereof be duly recorded as by law required, and that the Supervisor through whose District said road runs be directed to open the same for public use as a County Road.

In the matter of Proposed County Road No.541.:  
Commencing at a point on Tp. line between Tps.:  
2 & 3 N.R.30 E.W.M. where County Road No.265 :  
Crosses said Tp. line and running thence west :  
along said Tp. line until it intersects County ROAD No. 541  
Road No.300, and to vacate all that portion of:  
County Road No 265, from said point of begin- :  
ing which runs through sections 1 & 2 in Tp 2 :  
N.R.30 E.W.M. until it intersects County Road :  
No.300. :

Now on this day comes the report of the viewers, J. Barnhart, B.F. Renn and J.S. McLeod, heretofore appointed at the May term of this Court, to view and report upon the location of the above road as a county road, for final hearing, the same having been read at a previous day of this Court, to-wit: the July, 1902, term, and the said viewers having reported favorably and recommended the establishing of the same as a county Road, and the field notes and plat of survey being duly on file, and certified to by the surveyor appointed to survey the same, and there being no remonstrance, or claim for damages on file against said road,

IT IS THEREFORE ORDERED by the Court that the report of said viewers be accepted, and that the said road be established as a County Road in accordance with the report of said viewers, and that the said report, field notes and plat of survey thereof be recorded as by law required, and that the Supervisor through whose District said road runs be directed to open the same for public use as a County Road.
