In the matter of locating, establishing, changing and widening of a county road, the same being designated and commonly known as the Yoakum-Stage Gulch Market Road.

RESOLUTION

TO ALL WHOM IT MAY CONCERN, Greetings, WHEREAS, there now exists in Umatilla County, State of Oregon what is known as the Yoakum-Stage Gulch Market Road, the same being a county road and highway in the aforesaid county and state, and

WHEREAS, this being a regular term of the above entitled court now in regular session and sitting for the transaction of county business with all members of said court present;

NOW, therefore; BE IT RESOLVED by the county court of Umatilla County, State of Oregon that it is, and is hereby declared to be the intention of the said court to locate, establish, alter, widen, straighten and change a highway or road on or over a route as follows:

A strip of land sixty feet wide being thirty feet wide on each side of the center line of the Yoakum-Stage Gulch Market Road as surveyed over and across the North-east quarter of Section 2, Township 2 North, Range 30 East, W.M. The above mentioned center line being more particularly described as follows:

Beginning at a point on the Quarter Section line, 1965.9 feet West of the Quarter Section corner Common to Sections 1 and 2, Township 2 North, Range 30 East, W.M., thence North 17 degrees 57' East, 110.1 feet, thence on a curve to the right of radius 1432.5 feet, a distance of 228.4 feet, thence North 27 degrees 05' East, 154.8 feet, thence on a curve to the left of radius 1432.5 feet, a distance of 161.2 feet, thence North 20 degrees 38' East, 218.7 feet, thence on a curve to the right of radius 286.5 feet, a distance of 205.8 feet, thence North 61 degrees 48' East, 6.2 feet, thence on a curve to the right of radius 286.5 feet, a distance of 214.6 feet, thence South 75 degrees 17' East, 102.4 feet, thence on a curve to the left of radius 318.3 feet, a distance of 305.7 feet, thence North 49 degrees 41' East, 113.2 feet, thence on a curve to the right of radius 286.5 feet, a distance of 99.8 feet; thence North 29 degrees 44' East, 51.8 feet, thence on a curve to the right of radius 358.1 feet, a distance of 169.4 feet, thence North 56 degrees 56' East, 134.7 feet, thence on a curve to the left of radius 2865.0 feet, a distance of 254.2 feet, thence North 51 degrees 51' East, 436.6 feet, thence on a curve to the left of radius 1432.5 feet, a distance of 30.4 feet to a point on the Section line 727.0 feet South of the section corner, on the Township line, common to Sections 1 and 2, Township 2 North, Range 30 East W.M., containing ___ acres more or less,

BE IT FURTHER RESOLVED that a public necessity for said Road or Highway is hereby declared to exist for the following reasons, to-wit:

To straighten and eliminate the curves, to effect a suitable grade, and for the purpose of accomodating motor traffic, it is essential that the road be constructed over and across the lands hereinbefore described.

BE IT FURTHER RESOLVED that the District Attorney of Umatilla County, State of Oregon, be, and he is hereby requested and directed to bring such condemnation proceedings as may be necessary to condemn the said property as by law provided, for the purposes hereinabove referred to, and that a true copy of this resolution be duly entered in the commissioner's journal of said Court.
