RESOLUTION AND NOTICE OF INTENT TO ALTER AND RELOCATE COUNTY ROAD NO. 82)

TO WHOM IT MAY CONCERN:

WHEREAS, the hereinafter described county road is useless as a part of the general road system due to flood conditions of December 22, 1964, and burdensome to maintain and the public will be benefitted by its alteration and relocation, and

WHEREAS, it is deemed advisable that said county road be altered by resolution of this court, and

WHEREAS, the termini of said county road proposed to be altered is as follows, to-wit:

Section 31 T4N, R30, E.W.M. & Sections 25, 26 and 36 T4N, R29, E.W.M., the County Road No. 82 as established in 1880 and described as follows: Beginning at a point which bears S 81° 46'W-6, 007.1 ft. from Morehouse's House (now known as Ransier Ranch), thence N 28° W-9.5 ch. to Mile Post 18; thence, continuing N 28° W-33.5 ch. to angle post; thence, N 45° W-46.5 ch. to Mile Post 19; thence, continuing N 45° W-80.0 ch. to Mile Post 20; thence, continuing N 45° W-12.5 ch. to angle post; thence, N 20° W-67.5 ch. to that part vacated February 2, 1910, in Section 23 T4N, R29, E.W.M.

WHEREAS, it is necessary to alter the County Road and relocate it as follows, to-wit:

Beginning at Engineer's center line station 41+51.1, said station being 797 feet south and 3,312 feet east of the southwest corner of said Section 31, T4N, R30, E.W.M.; thence, N 11- 44'30"W-869.7 ft; thence, on arc of 2864.8 ft. radius curve right (the long cord of which bears N 5° 30'45")-622.9 ft.; thence, N 0° 43'E 325.9 ft.; thence, on the arc of 594.9 ft. radius left (the long cord of which bears S 19° 26'W)-671.7 ft.; thence, N 39° 35'W-636.7 ft.; thence, on arc of 2864.8 ft. radius curve left (the long cord of which bears N 45° 13'15"W)-563.8 ft.; thence, N 50° 51'30"W-396.6 ft.; thence, on the arc of 716.2 ft. radius curve right (the long cord of which bears N 17° 44'W)-827.9 ft. (to P.R.C.);

thence, on the arc of 716.2 ft. radius curve left (the long cord of which bears N 1° 51'45"W)-431.4 ft.; thence, N 19° 07'W-26.5 ft.; thence, on the arc of 716.2 ft. radius curve left (the long cord of which bears N 40° 11'W)-526.7 ft.; (P.R.C.) thence, on the arc of 716.2 ft. radius curve right (the long cord of which bears N 43° 12'30"W)-451.0 ft.; thence, N 25° 10'W-166.5 ft.; thence, on the arc of 716.2 ft. radius curve left (the long cord of which bears N 49° 02'40"W)-596.9 ft.; thence N 72° 55'20"W-107.6 ft.; thence, on the arc of 716.2 ft. radius curve (the long cord of which bears N 41° 03'45"W)-910.2 ft.; the said center line crosses the south and west line of said Section 31, T4N, R30, E.W.M., approximately at stations 49+50 and 116)50 respectively.

And also that part of Stage Gulch Road No. 82 beginning at Engineer's center line station 113+72.8, said station being 5,228 feet north and 240 feet east of the S.E. corner of said Section 36, T4N, R29, E.W.M; thence, on the arc of 716.2 ft. radius curve right (the long cord of which bears N 41° 03'45"W)-796.5 ft.; thence, N 9° 12'10"W-103.5 ft.; thence on arc of 1145.9 ft. radius curve left (the long cord of which bears N 37° 23'10"W)-1127.3 ft.; thence, N 65° 34'10"W-339.2 ft.; thence, on the arc of 5729.6 ft. radius curve right (the long cord of which bears N 12° 49'45"W)- 1282.9 ft.; thence, N 39° 54'40"W-2373.9 ft. to the center line of Despain Gulch Road. The said center line crosses the East and the North line of the said property approximately at stations 116+50 and 187+50 respectively.

WHEREAS, all of the real property over which the old county road now runs and which the new county road will run is owned by the Estate of Charles C. Hoskins;

NOW, THEREFORE, let be it resolved that pursuant to provisions of Chapter 368 of the Oregon Revised Statutes the 25th day of MARCH, 1966, be, and the same is hereby set as a hearing for any and all persons wishing to make objections to the proposed altering and relocating of County Road No. 82 to be afforded an opportunity to do so in the County Court Chambers in the County Courthouse at Pendleton, Oregon, at the hour of 10:00 a.m.

BE IT FURTHER RESOLVED that the County Road Master is ordered to post three copies of this Resolution and Notice of Intent to Alter and Relocate County Road No. 82 in the Umatilla County Courthouse and at three public places in the vicinity of the proposed County Road certified as true copies by the Umatilla County Clerk.

BE IT FURTHER RESOLVED that the Umatilla County Clerk is ordered to forward by mail, postage prepaid not less than thirty days prior to the 25th day of MARCH, 1966, a copy of this Resolution and Notice of Intent to Alter County Road No. 82 to the Administrators of the Estate of Charles C. Hoskins, Walter Holt, Jr., at Summerville, Oregon, and Samuel P. Haley, at 2013 Lloyd Center, Portland, Oregon, 97232.

BE IT FURTHER RESOLVED that upon the date set for hearing in this matter, if no satisfactory objections or remonstrances are presented, said County Road No. 82 will be altered by Umatilla County by agreement by excepting a Quit Claim Deed from the Estate of Charles C. Hoskins for the new proposed County Road and by Umatilla County executing a Quit Claim Deed to the Estate of Charles C. Hoskins for the area covered by the old county road pursuant to the authority vested in the County Court by ORS 368.470 (7).
