The undersigned has examined the road mentioned in the DEED hereinabove mentioned, and found said road is large in volume of vehicular traffic and to be in need of improvements. Further, this road will require extensive grading, some drainage (structures and culverts) as required, graveling and probably paving within short time.

It is my opinion that this road should be ACCEPTED; The road at present is being used and will be useful to the UMATILLA COUNTY road network and the general public will be benefited by the aforementioned action by said Court.

I CONCLUDE, therefore, and RECOMMEND that the said road be ACCEPTED and established as a COUNTY ROAD.
