ROAD NOTICE.

TO ALL PERSONS WHOM IT MAY CONCERN:

Notice is hereby given that a petition will be presented to the County Court of the State of Oregon, for Umatilla County, by the Undersigned who are freeholders of said County and State and reside in the road district or districts of the hereinafter described route for a County road, at the Ocelot term, 1913, of said County Court, to-wit: On the 1st day of October, 1913, praying said Court to alter and vacate a County road in said County and State, commencing, running and terminating as follows, to-wit:

That County Road No. 683, as petitioned for by Frank Sloan and others and as established by order of the County Court of Umatilla County Oregon, duly made and entered on the 4th day of March, 1910, be altered and vacated as follows:

(1) The following portion of said road, to-wit: Commencing at the Northeast corner of the Northwest Quarter of Sec. 34, Tp. 4 N. R. 29 E. W. M. and extending along said road No. 683 to the South line of Sec. 2 Tp. 4 N. R. 29 E. W. M., be reduced in width from 80 feet to 40 feet, so that said road shall extend 20 feet on each side of the center line thereof as now laid out and established, and all of said portion of such road now lying and being at a greater distance than 20 feet from the center line thereof be vacated.

(2) The following portion of said road, to-wit: Commencing at the Southeast corner of the Northwest Quarter of Sec. 34, Tp. 4 N. R. 29 E. W. M. and running to the Northeast corner of the said Northwest Quarter of said Sec. 34, be reduced in width from 80 feet to 40 feet by vacating the Westerly 40 feet of said road, so that said road as altered shall be 40 feet in width and shall extend 40 feet Easterly from the North and South center line through said Sec. 34, and that such portion of said road now lying West of such North and South center line be vacated.

(3) The following portion of said road, to-wit: Commencing at the Southwest corner of the Northwest Quarter of Sec. 34, Tp. 4 N. R. 29 E. W. M. and running to the Southeast corner of the Northwest Quarter of said Sec. 34, Tp. 4 N. R. 29, be vacated.
