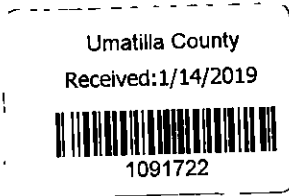

### ACCESS AND UTILITY EASEMENT

**Windblown Ranch, Inc., A.K.A. Wind Blown Ranch, Inc., an Oregon corporation, Grantor, conveys and warrants to Patrick Walchli, Grantee, a perpetual non-exclusive easement for ingress-egress and utility purposes, the following described real property:**

The South 30.00 feet of the Northwest quarter of Section 16 and the North 30.00 feet of Southwest quarter of Section 16, all in Township 4 North, Range 29 East, Willamette Meridian, Umatilla County, Oregon, lying westerly of the westerly right-of-way margin of South Edwards Road, County Road Number 1201, more particularly described as follows:

Beginning at the Southwest corner of the Northwest quarter of said Section 16; Thence North 00°53'52" West, along the West line of the Northwest quarter of said Section 16 for a distance of 30.00 feet; Thence leaving the West line of the Northwest quarter of said Section 16, North 88°08'07" East, 39.02 feet to the westerly right-of-way margin of said South Edwards Road, being 30.00 feet westerly and at right angles to the centerline thereof; Thence South 02°19'11" East, along the westerly right-of-way margin of said South Edwards Road for a distance of 60.00 feet; Thence leaving the westerly right-of-way margin of said South Edwards Road, South 88°08'07" West, 40.51 feet to the West line of the Southwest quarter of said Section 16; Thence North 00°53'29" West, along the West line of the Southwest quarter of said Section 16 for a distance of 30.00 feet to the Point of Beginning.


