INTRODUCTION & BACKGROUND

The Umatilla County Board of Commissioners issued an Order February 13, 1997 for a portion of South Edwards Road to be surveyed in anticipation of legalization (SV97-02). The Umatilla County Director of Public Works had determined the existing records of a portion of South Edwards Road do not agree with the location of the road as traveled and used for 10 years or more, and the portion of road between East Harding Avenue and East Highland Extension was assumed to have been constructed using a defective survey.

The Public Works Department intends to legalize the portion of South Edwards Road as described in the Board Order. The survey has been completed and all of the necessary notifications have been made.

HISTORY & CURRENT USE

South Edwards Road was petitioned for on May 31, 1906 at a total width of 60.00 feet. Notice was posted of the proposed road establishment that same day. The report of Board of County Road Viewers, survey, and field notes were all completed in August of 1906 where the route was found practicable and recommended to be established and declared a public highway, with the exception of the first one half mile as it was determined was already a portion of established county road no. 477. The final order (Old Road #596) was filed September 10, 1906 officially opening the road for public use.

The road was in use as a dirt/gravel road from its opening in 1906 to the mid-1970's at which time multiple chip-seal layers were added. Historical imagery from 1952 clearly shows South Edwards Road as a dirt/gravel road. The alignment of the road in the 1952 aerial matches the alignment as exists today, verifying its long term use and location. South Edwards Road currently receives around 1,300 vehicles per day and is easily within the top 20 Umatilla County Roads when considering average daily traffic volume.

WHY A ROAD LEGALIZATION IS NEEDED

The record alignment of South Edwards Road as described in the 1906 road establishment documents follows the north-south Section lines between Sections 8, 9, 16, 17, 20, 21, 28, 29, 32 & 33. The center of the physical road location deviates easterly from the record section lines anywhere between 0 feet to 150 feet between East Harding Avenue and East Loop Road. This creates thousands of feet of road outside of the record right-of-way location. The legalization will correct this, centering the right-of-way on the physical road location as intended.


IMPACTS TO UTILITIES AND PROPERTY OWNERS

Legalizing South Edwards Road in the location as shown on the road survey may have some impact to utilities currently within or adjoining the road right-of-way. Survey field ties to existing utility structures indicate that there may be some overhead power outside of the proposed right-of-way. Much of the overhead power in this corridor is covered by additional easement; however, the utility company (UEC) has been notified of the potential issue and will be evaluating internally. All other permitted utility companies appear to be within the proposed right-of-way. It is ultimately the utility companies' responsibility to verify this. All utility companies have been properly notified of the proposed legalization.

The Public Works Department finds no adverse impacts to adjoining property owners at this time. Legalizing South Edwards Road in the location as shown on the road survey fits current improvements and fence-lines well, and keeps any improvements made by adjoining owners outside of the right-of-way. In some areas, easements are needed for adjoining owners to preserve access to the public right-of-way. These easements are clearly shown on the road survey (recorded as 19-004-B, Umatilla County Survey Records) and have been recorded as required by the Public Works Department (see instrument numbers 2019-6810355 to 2019-6810364, Umatilla County Records).

RECOMMENDATION

The Umatilla County Public Works Department recommends that South Edwards Road, County Road 1201 be legalized between East Harding Avenue and East Loop Road at the location and widths shown on the road survey, pursuant to ORS 368.201 to 368.221.

Good morning, Matt – I have researched the records of survey's that you provided to me. It appears that our property runs along S Edwards Rd on the West side (see sheet 5 and 6 of 13). If you could please submit this email for consideration and to address our concerns to The Umatilla County Board of Commissioners for the upcoming hearing taking place on January 9, 2019 that would be greatly appreciated.

The main concerns is that according to the legend, the proposed legalization Right-of-Way (ROW) line would encroach into one of our circles that is currently being farmed with water rights. LoyAlta Inc does have concerns with the proposed ROW line. We have been farming this section for many decades and we want to make sure that we continue to do so under our right of Adverse Possession law as it has been our understanding that our property line runs right up to the gravel/pavement area.

Additionally there is the overhead powerlines that the proposed ROW line would occupy. The overhead lines are not noted or included in the survey's even though they are visibly present. How is the county dealing with those utility with regard to the post? I believe UEC has easements for those powerlines.
