

FIELD NOTES OF ROAD NO 758

Commencing at a point 150 feet South of the NW corner of the SW $\frac{1}{4}$ of Section 4, T, 3, N, R 29 E.W.M. I set a post 4x4 ins square $3\frac{1}{2}$ feet long 18 ins in the ground 30 feet North of the initial point Marked N No, 758 dug pits east and North 5 feet distant, and raised a mound 4 feet Base 18 ins high around post.

Thence S, 83°30' E 3,52	chains,	Distance	A,1
" N, 68°40' E 1,66	"	5,18	A,2
" N, 28° E 2,44	"	7,62	A, T, No. 758

Set post 4x4 ins square $3\frac{1}{2}$ feet long 18 ins in the ground 30 feet North of terminus marked R T, No. 758 dug pits E & W of post 5 feet distant, and raised mound of earth 4 feet base 18 ins, high around post.

REPORT OF BOARD OF COUNTY ROAD VIEWERS.

In the Matter of viewing, Surveying and laying out County Road No. 683.

To the Honorable County Court of the State of Oregon, for Umatilla County.

We, the undersigned Board of County Road Viewers, heretofore instructed to view, survey, and locate Road No. 683, submit the following report:

Pursuant to an order of the Honorable County Court, we met at Pendleton, Oregon on the 13th day of October, 1913.

We called to our aid

L.C. Rothrock, Chairman
H.C. Mills, Flagman

who were by the Surveyor each duly sworn We viewed, surveyed and located said Road No. 683 as specified in our order. We find said route as represented and that portion of said road lying East and West through the center of the W $\frac{1}{2}$ of Section 34 T, 3 N.R. 29 E.W.M. Petition should be granted, and same be vacated, and that portion of said road running N & S through center of the N $\frac{1}{2}$ of Section 34, T. 4 N.R. 29 E.W.M. as follows, to-wit: The West $\frac{1}{2}$ 40 feet wide on the west side of the center line be vacated as petitioned for. And the east $\frac{1}{2}$ 40 feet wide on the East side of the center line be declared a public highway as petitioned for. And that portion described as Commencing at the NE corner of the NW $\frac{1}{4}$ of Section 34 T 4 N.R. 29 E.W.M. thence North 80.00 to the NE corner of the NW $\frac{1}{4}$ of Section 27 thence East 80,00 chs. to the NE corner of the NW $\frac{1}{4}$ of Section 26, thence North through the center of sections 23-14 and 11, T 4 N.R. 29 E.W.M. 240 chains 3 miles, to the South boundary of section 2 that the petition be granted, to-wit: vacating all of that portion lying more than 20 feet to the right and left of the center line as above described, and 40 feet or 20 feet wide on each side of the center line be declared a public highway, of Umatilla County, Oregon.
