ORDER VACATING COUNTY ROAD

NOW ON THIS DAY THIS MATTER coming on now to be heard, this being the time and place set by the court for hearing upon this matter; and it appearing to the court that due and lawful advertisement of the Final Hearing has been given by posting of three true copies of the Notice of Hearing on file herein at three public places in the vicinity of said road and at one public place of said County where public notices are usually posted and as shown by the Affidavit of Posting on file herein; that each of said notices remained so posted for more than thirty days thereafter; and it appearing that due proof of the posting of said Notices is now before the Court and it appearing that no objections have been made or filed to such proposed vacation, and it further appearing that said portion of said road so proposed to be vacated is not useful as a part of the general road system of Umatilla County, Oregon, and that the public will be benefited by the vacation there, and it further appearing that said road is not now used; and it further appearing that this court erroneously issued a previous order vacating the following described portion of County Road 609,

It is THEREFORE; ORDERED, ADJUDGED, AND DECREED that the following described portion of said road be vacated.

That portion of County Road No. 609, which is more particularly described as commencing at a point 5.9 chains south of the Northwest corner of Section 21, T4N, R28, E.W.M.; thence North 78° 00' E-25.7 chains to the relocated center line viz. Along the division line of the said Section 21, and Section 16, T4N, R28, E.W.M. and which lies outside of the following described reconstructed and relocated portion of said County Road No. 609, to-wit: Beginning at Engineer's center line station 0+00, said station being 9.21' south and 1706.84' east of the northwest corner of said Section 21, T4N, R28, E.W.M.; thence N89° 41' W-20.6'; thence on 14° arc 409.26 radius curve left (the long chord of which bears S79° 20 1/2' W)-156.8'; thence S68° 22' W-1.1'; thence 5 1/2° arc 1,041.74' radius curve right (the long chord of which bears S87° 17 1/2' W)-690.3'; thence N73° 47' W-5.4'; thence on 12- arc 477.46' radius curve left (the long chord of which bears S82° 27 1/2' W)-396.0'; thence S58° 42' W-546.9', to a point which is 398.2 feet south of the said Section 21, T4N, R28, E.W.M.

for the reason that said portion of said road is useless and burdensome, is of no value either to individuals or to the general public; that the same is useless as a part of the general road system of Umatilla County, Oregon, and that the public will be benefited by the vacation of the same; and

It is FURTHER ORDERED, ADJUDGED AND DECREED that the previous Order Vacating the above-described portion of County Road No. 609 be, and the same is hereby, declared to be void and is hereby held for naught.
