Now on this day this matter coming on regularly to be heard upon the report of the Board of County Road Viewers heretofore instructed at the January 1907 Term of this Court, to view, survey, and report upon said proposed Road No. 508, commencing at the North West corner of Section 28, Township 4 North, range 28 E. W. M.; thence East along Section lines as nearly as practicable to the South East corner of Section 24, Township 4 North, Range 28 E. W. M, there intersecting the East boundary line of said Township 4, and there terminating, as a County road for final hearing, the same having been publicly read on two different days of the same term of Court, to-wit: Having been publicly read the first time on the 5th day of March 1907, and publicly read the 2nd time on the 8th day of March, 1907, and the Board of County Road Viewers having reported favorably and recommended the opening of said road as a county road, and the field notes being on file and certified to by the Surveyor appointed to survey the same, and the Court being satisfied that said road would be of sufficient utility, it is therefore hereby ORDERED that said report of the Board of County Road Viewers be accepted, and the plat and field notes be recorded in the records of plats and field notes of Umatilla County, and that the road supervisor through whose district said road runs, be and he is hereby ordered and instructed to open the same for public use.

W. M.; thence East along Section line as nearly as practicable to the South East corner of Section 8, Township 4 North, range 29 E. W. M. there meeting the road projected North from the town (now city) of Echo, Oregon and there terminating, as a county road for final hearing, the same having been publicly read on two different days of the same term of Court, to-wit: Having been publicly read the 1st time on the 6th day of March, 1907, and publicly read the 2nd time on the 8th day of March, 1907, and the said Board of County Road Viewers having reported favorably and recommended the establishing of said road as a county road, and the field notes and plat of survey being on file and certified to by the surveyor appointed to survey the same, and the Court being satisfied that said road would be of sufficient public utility, it is therefore hereby ORDERED that said report of the Board of County Road Viewers be accepted, and that plats, report and field notes be recorded in the records of plats and field notes of Umatilla County, and that the road supervisor through whose district said road runs, be and he is hereby ordered and instructed to open the same for public use.
