Now on this day this matter coming on regularly to be heard upon the report of the County Road Viewers heretofore instructed by the Court to view, survey and report upon said road which is proposed to be vacated, petitioned for as follows: In the Northwest Quarter of the Northeast Quarter of Section 30, Township 4 North, Range 28 East, W. M., the same being in Road District No.36 of said County, the center line of the road to be vacated being particularly described as follows, to-wit: Beginning at a point in the Center line of the present county road which said point is also in the center line of said Section 30 and which said point bears S81° 32' East a distance of 2459.4 feet from the northwest corner of Section 30; thence south on the center line of said section a distance of 900 feet; thence southeasterly to a point which is 1619.1 feet south and 2922.5 feet east of the northwest corner of said section, of a County Road, the same having been publicly read on two different days of the same term of Court, and the said Board of County Road Viewers having reported favorably and recommended that said road be vacated at such time when County Road No. 775 shall have been established and opened to the general public and that the plat and field notes bei-ng on file, and there being no remonstrance or objections on file against said report and the Court being satisfied that said road is not of sufficient public utility,

IT IS THEREFORE HEREBY ORDERED that said report of the Board of County Road Viewers be approved and that said road be vacated and that to the plat and field notes be recorded in the record of plats and field notes of Umatilla County and that the Road supervisor through whose district said road is now established be, when and he is hereby ordered and instructed to close the same to the public travel.


