ORDER NO. RD2002-12

WHEREAS, the Umatilla County Board of Commissioners may, under authority of ORS 368.201 to 368.221, order a county road that has been used and traveled by the public for ten (10) years or more to be surveyed and recorded, and

WHEREAS, the Umatilla County Board of Commissioners ordered the survey of Culp Lane (County Road #1267) lying approximately 1 3/4 miles east of the intersection of County Road No. 1250 (Punkin Center Road) and U. S. Highway No. 395 in Section 36, Township 5 North, Range 28 E.W.M., and

WHEREAS, the Notice of Hearing was posted and all owners of abutting property affected by the legalization procedure were served copies of the Notice of Hearing, and

WHEREAS, the Umatilla County Board of Commissioners on August 7, 2002, continued to August 14, 2002, held a public hearing and finding that it would be in the public interest to legalize the road:

THEREFORE IT IS NOW ORDERED that the road be legalized as follows:

Commencing at a brass cap marking the Southwest Corner of Section 36, Township 5 North, Range 28 E.W.M.; thence S89°44'35"E, 2656.08 feet to a brass cap near the South 1/4 Corner of said Section 36; thence N00°16'16"W, 33.15 feet to the northerly right-of-way line of County Road No. 1250, Punkin Center Road, and the true point of beginning; thence N00°16'16"W, 1278.44 feet to a 2-inch iron pipe; thence N00°03'38"E, 1276.54 feet to a 5/8-inch iron rebar; thence S89°38'51"E, 22.99 feet to a 5/8-inch iron rebar; thence N00°21'09"E, 40.00 feet to a 5/8-inch iron rebar; thence N89°38'51"W, 20.00 feet to a 2½-inch brass cap set near the center of Section 36; thence N89°38'51"W, 43.20 feet to a 5/8-inch iron rebar; thence S00°03'38"W, 658.43 feet to a 5/8-inch iron rebar; thence S00°03'38"W, 658.43 feet to a 5/8-inch iron rebar; thence S00°16'16"E, 639.10 feet to a 5/8-inch iron rebar; thence S00°16'16"E, 639.10 feet to the northerly right-of-way line of County Road No. 1250; thence S89°44'47"E, 32.90 feet along said northerly right-of-way line; thence S89°44'13"E, 7.10 feet along said northerly right-of-way line to the point of beginning.


The plat of the above described road is filed in the Umatilla County Surveyor's Office and is recorded as Survey No. 02-171-C.
