) REPORT OF COUNTY  
) ROAD VIEWERS

TO THE HONORABLE COUNTY COURT OF UMATILLA COUNTY, STATE  
OF OREGON:

We, the undersigned Board of County Road Viewers, hereto-  
fore appointed and qualified as a Board of County Road Viewers to  
view, survey if necessary, lay out, locate, relocate or change the  
above mentioned road, submit the following report:

Pursuant to the order of the above entitled Court, we met  
at the point of beginning of the above mentioned proposed road  
on the 27 day of May, 1948, and having qualified  
as viewers, proceeded to view the proposed road in the following  
manner:

Starting at the initial point designated in the Resolution  
we followed the most practical route for the purpose of definitely  
locating and located said road as follows:

Beginning at the center of the intersection of 3rd.  
Street and the East City Limits of the City of Umatilla,  
Oregon, the centerline of which shall run N. 73° 13' E.  
a distance of 625.2 feet, said portion of the above  
described road shall be 60 feet in width. Thence con-  
tinuing N. 73° 13' E. a distance of 870 feet, more or less  
to a point, this portion of the road shall be 70 feet in  
width. Thence continuing N. 73° 13' E. a distance of  
2640 feet. This portion of the road shall be 80 feet in  
width. Thence continuing N. 73° 13' E. a distance of  
1004.6 feet more or less to a point on the West line of  
Tax No. 2 of Section 9, Tp. 5 N., R. 28, E.W.M. This  
portion of the road last above described shall be 60 feet  
in width.

We find the proposed road as located to be a feasible and  
necessary one, and a benefit to the public, therefore we respectfully  
recommend that it be opened and established as a County Road of  
Umatilla County, Oregon.

We find that the property adjoining and which said road  
crosses is benefited by the establishment of said road and that said  
land is not rendered less valuable by reason of the location of said

road and that it is damaged in the sum of nothing.

That attached hereto and made a part of this report is a plat of the preliminary line of survey, showing the alignment of the proposed road the the general topography adjacent and showing the tie to government corners along the road where available, which plat and report is submitted herewith, attached hereto, marked Exhibit "A" and made a part of this report.
