of Section 27 Township 2 North Range 32 East W. M. Beginning at Station 13 & 50 of the said Highway Survey which Station is approximately 1083 feet North and feet of the Section Corner which is common to Sections 27, 28, 33 and 34 Township 2 North Range 32 East W. M. Thence running in a Northeasterly direction approximately 600 feet to Station 19 & 50 of the said survey, which Station is approximately in the feet and feet center of the corner which is common to Sections County Road No. 483 Township Range East W.
