paid to it the receipt whereof is hereby acknowledged has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: ~~xxx~~ A strip of land thirty feet wide on the South side of the center line of County Road No. 616 as laid out along the North side of the Northwest Quarter of the Southwest Quarter of Section 32, Township 4 North, Range 28 East, W.M. Said strip of land being more particularly described as follows; Beginning at the Quarter Section corner common to Sections 31 and 32, thence South along the Section line 30 feet, thence East parallel to the Quarter Section line approximately 1320 feet to the 1/16 Section line, thence North 30 feet to the Northeast corner of the Northwest Quarter of the Southwest Quarter of Section 32, thence West along the Quarter Section line approximately 1320 feet to the place of beginning. All in Township 4 North, Range 28 East, W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
