paid to them the receipt whereof is hereby acknowledged

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land thirty feet wide on the south side of the center line of County Road 616 as laid out along the north side of the Northwest Quarter of the Southwest Quarter of Section 33, Township 4 North, Range 28 East, W.M. Said strip of land being more particularly described as follows; Beginning at the Quarter Section corner common to Sections 32 and 33, thence South along the Section line, 30 feet, thence East, parallel to the Quarter Section line, approximately 1320 feet to the 1/16 Section line, thence North, 30 feet, to the Northeast corner of the said Northwest Quarter of the Southwest Quarter of Section 33, thence West, approximately 1320 feet to the place of beginning. All in Township 4 North, Range 28 East, W.M.

This County agrees to put up dikes and to replace the fence along this Road.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
