Report of viewers, field notes and Plat of Road No 375 in Umatilla County, Oregon, commencing at the SW corner of the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 17 Township 3 N of Range 29 E W. M., thence north $\frac{1}{4}$ of a mile, thence west one half mile, thence north one mile, thence west $\frac{1}{4}$ of a mile to the half mile stake between sections 7 + 8, thence north $\frac{1}{2}$ mile to the NW corner of Sec. 8, thence west one mile on the section line between sections 6 + 7, all the above described in township 3 N of Range 29 E W. M., thence west along the section line between sections one and twelve in Township 3 N of Range 29 E W. M. one mile, thence South $\frac{1}{2}$ mile on section line between sections 11 + 12, thence west one half mile, thence south one half mile to the section line between sections 11 + 14, thence west on said section line as near as practical on the line sections 11-14-10 + 15 one and one half miles, thence south one half mile, thence west on the center line of sections 16 + 17 to the intersection of the county Road leading from Umatilla up the East side of Butler Creek
