of the County of Umatilla ~~in the State of Oregon~~, in consideration of the benefits and other valuable considerations, and the sum of One and No/100 Dollar paid to them, the receipt whereof is hereby acknowledged, by them have granted, bargained, sold and conveyed, and by these presents do <sup>es</sup> grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit:

A strip of land 40 feet wide being 20 feet on each side of the center line as surveyed over and across the SW<sup>1</sup>/<sub>4</sub> of SW<sup>1</sup>/<sub>4</sub> of section 5, and S<sup>1</sup>/<sub>2</sub> of SE<sup>1</sup>/<sub>4</sub> and SE<sup>1</sup>/<sub>4</sub> of SW<sup>1</sup>/<sub>4</sub> section 6, Township 1 North, Range 32, E.W.M., and described as follows:

Beginning at a point which point is 760 feet north of the southeast corner of SW<sup>1</sup>/<sub>4</sub> of SW<sup>1</sup>/<sub>4</sub> of section 5, Twp. 1 North, Range 32, E.W.M.; thence around an 8° curve left for a distance of 359 feet; thence on a tangent with a bearing of South 75° 21' West for a distance of 410 feet; thence around a 2° curve right for a distance of 240 feet; thence on a tangent with a bearing of 80° 09' W for a distance of 906 feet, thence around a 6° curve right for a distance of 366 feet; thence on a tangent with a bearing of North 77° 52' West for a distance of 719 feet; thence on an 8° curve left for a distance of 250 feet; thence on a tangent with a bearing of South 82° 10' West for a distance of 582 feet; thence on a 4° curve left for a distance of 255 feet; thence on a tangent with a bearing of South 71° 57' West for a distance of 590 feet; thence on an 8° curve right for a distance of 210 feet; thence on a tangent with a bearing of South 88° 43' West a distance of 465 feet to a point 80 feet north of the southwest corner of the SE<sup>1</sup>/<sub>4</sub> of SW<sup>1</sup>/<sub>4</sub> of Section 6, Twp. 1 North, Range 32, E.W.M., and containing 4.91 acres,
