

To the Honorable County Court of the State of Oregon,
for Umatilla County:

We, the undersigned, your petitioners, who are residents and householders in Umatilla County, Oregon, and all of whom reside in the vicinity of that portion of the hereinafter described County Road prayed to be vacated, respectfully petition your Honorable Body to cause to be vacated and to vacate the following portion of County Road No.326, of Umatilla County, Oregon, to-wit:

All that part of said County Road which lies in Township 2 North and Range 29 East of the Willamette Meridian, which part of said County Road is particularly described as follows: Commencing near the Southeast corner of the Northeast Quarter of Section 1, in Township 2 North and Range 29 East of the Willamette Meridian, in said Umatilla County, where said County Road No. 326 crosses the section line on the East side of said Section One; running along said County road Southwesterly across the Southeast Quarter of said Section One and the North Half of Section 12, and the East Half of section 11, in said Township and Range, to a point near the center of said Section 11; thence running North and still following said County Road, about 40 rods; thence running Westerly and following said County Road, to the West line of said Section 11, thence running South and still following said County Road, on said Section line between Sections 10, 11; 14 and 15, 22 and 23, 26 and 27, all in said Township and Range, to a point on the West side of said Section 26 near the Southwest corner of the Northwest Quarter of said Section 26, where said County Road No. 326 intersects the section line on the West side of said Section 26; thence running Southeasterly, and still following said County Road, across said Section 26 to a point near the Northwest corner of the Southeast Quarter of said Section 26; thence still following said County Road No.326 in a Southwesterly direction across the South Half of

said section 26 and into Section 35, to a point near the center of the Northwest Quarter of said Section 35, in said Township and Range; thence Running Southeasterly and still following said County Road, across the North Half of said Section 35 and the North Half of Section 36, in said Township and Range, to a point near the center of said Section 36 where the said County Road No.326 terminates; the several courses and directions above described follow along so much of said County Road No.326 as lies in Township 2 North and Range 29, East of the Willamette Meridian, in Umatilla County, Oregon, and constitutes all of that part of said County Road in said Township and Range.*
