In this matter the Court Finds that the Viewers and Surveyor appointed on May 6, 1903.

met at the time and place fixed by the Court, when and where each of them took the oath
by law required and they then took two suitable persons to act as chain bearers and then
proceeded to perform their duties as the law directs, that a report of the said Viewers,
with a correct certified return of the survey of that portion of said road asked to be
vacated, and a plat of the same, made and certified by the Surveyor, were filed with the
Clerk of this Court on June 25, 1903, prior to the first day of this term of Court, which
report of Viewers is in favor of the vacation of the said portion of the road asked to be
vacated; and now said report of the Viewers having been duly read in open Court on two
different days prior to this day, at this term of Court, and no remonstrance nor any objection of any kind, nor any petition for damages having been filed or made by any person,
and the Court having examined into all of the matters connected herewith and all of the
papers filed and orders made heretofore, and being now satisfied that the portion of the said papers filed and orders made heretofore, and being now satisfied that the portion of t road asked to be vacated by the petition of S P Gould, W M Slusher and others, in this matter, should be vacated and that the same can be vacated without injury, damage, or portion of the said

It is THEREFORE NOW BY THE COURT CONSIDERED, ORDERED and decreed that the said report, survey and plat be and they are hereby approved, ratified, and confirmed, and they shall be recorded in the proper records of this Court and of Umatilla County, oregon, and from this time forth that portion of the said County Road No. 326 asked to be vacated, to-wit: All of that part of said County Road No. 326 which lies in Township 2 North and Range 29 East of the Willamette Meridian which part of said County Road is particularly described as follows: Commencing near the Southeast corner of the Northeast quarter of section 1 in Township 2 North and Range 29 East of the Willamette Meridian, in Umatilla County, Oregon, where said County Road No 326 crosses the section line on the East side of said section 1. running thence along said County Road Southwesterly across the Southeast quarter of said Section 1, and the North Half of Oction 12, and the East Half of section 11, in said Township and Range, to a point near the center of said section 11; thence running North and still following said County Road bout 40 road; thence running Westerly and still following said County Road on the section line between Section 10 and 11, 14, and 15, 22, and 23, 26 and 27, all in said township and range, to a point on the West side of said section 26, thence running Nouth-easterly and still following said County Road and township and range, to a point near the resorts and section 26, thence running Southwest corner of the Northwest Quarter thereof, where said County Road No. 326 in a Southwesterly direction across the South Half of said section 25 in said township and Range; thence running Southeast and annulled and no longer a highway or public thoroughfare.
