NOTICE OF HEARING

Notice is hereby Given, pursuant to order of the County Court of the State of Oregon for Umatilla County, dated the 26th day of April, 1956, that the 5th day of June, 1956, at 10:00 A.M. of said day, is fixed as the date and time and the County Court Room of the County Court House of Umatilla County, in Pendleton, Oregon, as the place for a public hearing before the above Court to consider any objections or testimony offered by any person interested and determine whether it is necessary and expedient and for the best interests of Umatilla County, Oregon, to surrender jurisdiction over a portion of County Road No. 842½, the same being more particularly described as follows:

Beginning at Section corner common to Sections 16 and 17, Township 1 South, Range 32 East, of the Willamette Meridian; thence West 563.98 feet, thence North 11 degrees 38 minutes West, a distance of 290.2 feet to the true point of beginning of McDevitt Addition, to the Town of Pilot Rock, point also being Centerline of County Road 842½. Thence along said Centerline of said County Road North 11 degrees 38 minutes West a distance of 989.21 feet, thence South 13 degrees 9 minutes East, a distance of 1083.70 feet to point of curvature, Station 28 plus 88.30, thence on a 4 degree curve to the right, a distance of 207.7 feet to the South line of Section 17, Township 1 South, Range 32 East, of the Willamette Meridian; said Right-of-Way being 60 feet in width, 30 feet on either side of the foregoing described Centerline.
