WE THE UNDERSIGNED, your petitioners, who are freeholders of said Umatilla County, Oregon, and who reside in the road district where said road is to be laid out, respectfully petition your honorable body to cause to be laid out, located, and established a County Road in said County and State, commencing, running and terminating as follows, to-wit: Commencing at the Southeast corner of Northeast quarter of Section 13 in Township I South of Range 30 1/2 E. W. M., thence North 73° East 488 feet; thence North 59° East 847 feet; thence North 45° East 1129 feet; thence North 49° East 1125 feet; thence North 41° East 1691 feet to a post set in the ground marked I mile post; thence North 41° East 255 feet; thence North 34° East 1954 feet to the Northeast corner of Southeast quarter ~~of~~ of Section 7 in Township I South of Range 31 E. W. M., thence East through the center of Section 8 in Township I South of Range 31 E. W. M., 3071 feet to a post set in the ground marked 2 mile post; thence East 315 feet; thence North $66^{\circ} 30'$ East 1357 feet; thence North 50° East 1738 feet; thence North 44° East 1435 feet; thence North $31^{\circ} 15'$ East 435 feet to a post set in the ground marked 3 mile post; thence North $21^{\circ} 15'$ East 2447 feet to the center of Section 4 in Township I South of Range 31 E. W. M.; thence North to Northwest corner of Northeast quarter of Section 4 in Township I South of Range 31 E. W. M., at base line; thence east to Southwest corner of Southeast quarter 287 feet in Section 33 in Township 1 North of Range 31 E. W. M., to a post set in the ground marked 4 mile post; thence North $19^{\circ} 30'$ East 2800 feet; thence East 1023^{feet}; thence 48° East 1050 feet; thence North 42 feet to a post set in the ground marked 5 mile post; thence North 1493 feet to the Southwest corner of Section ~~27~~ 27 in Township I North of Range 31 E. W. M., thence East to the Southeast corner of Southwest quarter of Section 24 in Township I North of Range 31 E. W. M., thence North to the center of Section 24 in Township I North of Range 31 E. W. M.,; thence East to the Township line to the Southeast corner of Northeast quarter of Section 24 in Township I North of Range 31 E. W. M.,; thence North along the Township line between Sections 19 and 24 and Sections 13 and 18 a distance of 7438 feet to a point on said Township line; thence North 86° East 520 feet; thence North 23° East 495 feet; thence East 1157 feet to a post set in the ground marked 11 mile post; thence East 1137 feet to the Southeast corner of Southwest quarter of Section 7 in Township I North of Range 32 E. W. M.,; ~~thence North~~ ~~45° East 45 feet~~; thence East to the Southeast corner of Section 7 in Township I North of Range 32 E. W. M., thence North to the Northeast corner of Section 7 in Township I North of Range 32 E. W. M., thence East to the Southeast corner of Southwest quarter of Section 5 in Township I North of Range 32 E. W. M.,; thence North 6° East 520 feet; thence North 38° East 285 feet; thence North 77° East 1990 feet; thence North 67° East 363 feet; thence North 42° East 355 feet to a post set in the ground on the east line of Southeast quarter of Section 5 in Township I North of Range 32 E. W. M., intersecting a County Road.

Said Road to be 40 feet wide.
