have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land 60 feet wide, being 30 feet wide on each side of the center line of said road as surveyed over and across Section 19 and the North-west Quarter of Section 20, Township 1 South, Range 32 East, W.M. Said center line being more particularly described as follows; Beginning at a point known and designated as Station 5 / 50 of the said road survey, which point is 1320 feet South and 325 feet West of the Section corner common to Sections 17, 18, 19 and 20, Township 1 South, Range 32 East, W.M., thence South 33 36' West, a distance of 5450 feet to a point known and designated as Station 60 / 00 of the said survey, which Station is 570 feet South and 859 feet West of the Quarter Section corner common to Sections 19 and 30, Township 1 South, Range 32 East, W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
