

In the County Court of the State of Oregon
for Umatilla County

In the matter of a County Road
from Pendleton to the Mouth of
Desolation Creek in Sec. 36 T6 S.R.
31 E. W.M.

The undersigned citizens and householders
of Umatilla County, State of Oregon, residing
in the vicinity of the hereinafter particularly
described proposed County Road respectfully
petition the above entitled County Court
that an order be made by your Hon. Body
for the laying out, location of and establish-
ment of a County Road from the South bound-
ary line of the town of Pendleton in said
County and State by the most practicable
route in a South Westerly direction to the
Mouth of Desolation Creek in Section 36 T6 S.R.
31 E. W.M. upon substantially the following
lines to-wit: Commencing at the South
End of Walnut Street in the town of Pendleton
in said County and State, between the South
West Corner of Block No. 279 and the South East
Corner of Block No. 280 of the Reservation ad-
joining to said town of Pendleton, in the middle
of said Street, and running thence in a
South Westerly direction on or near the line of the
present County Road from Pendleton to Pilot Rock
on the most practicable route to the upper
Bridges over McKay Creek on said Pendleton and

Pilot Rock Road as the same is now travelled, thence in a South westerly direction on or near the line of the present County Road from Puddleton to Pilot Rock on the most practicable route to the town of Pilot Rock in said County and State; thence in a South-erly direction on or near the line of the County Road as now travelled on the most practicable route to High Bridge on Birch Creek where the County Road from Pilot Rock to Camas Prairie now crosses said Birch Creek in Sections 21 and 22 T. 2 S. R. 31 E. W. M.; thence in a South Easterly direction on the most practicable route to within thirty yards west of Millers sheep camp near the middle of Section twelve (12) T. 3 S. R. 31 E. W. M.; thence by most practicable route by the place known as "the yellow jacket" to the "Cold Spring" in Section 36 T. 3 S. R. 31 E. W. M. in a Southerly direction; thence in a Southerly direction by the most practicable route to the Range Line between Ranges 31 and 32 in T. 4 South - East of the Willamette Meridian; thence South on or near said Range line by most practicable route to North East Corner Sec. 24 T. 4 S. R. 31 E. W. M.; thence West on section line between Sections 13 and 24 T. 4 S. R. 31 E. W. M. to a point due north of Clifford's Store; thence Southerly by Clifford's Store to the section line between Sections 24 and 25 T. 4, S. R. 31 E. W. M. on the most practicable route to

the corner between sections 23 and 24; 25 and
 26 T. 4 S. R. 31 E. W.M.; thence southerly on or
 near section line between sections 25 and 26;
 35 and 36 on the most practicable route to
 township line between Twp. 4 and 5 S. R. 31 E.
 W.M.; thence southerly on or near section
 line between sections 1 and 2; 12 and 11; 13
 and 14; 23 and 24; 25 and 26; 35 and 36 on
 the most practicable route to township line
 between Townships 5 and 6 South Range 31
 E. W.M.; thence by the most practicable
 route in a southerly direction to mouth
 of Desolation Creek in section 36 T. 6 S. R.
 31 E. W.M. on the John Day River -
