NOW ON THIS DAY this matter coming on to be heard, this being the time and term for the final decision of the court upon said matter.

It appearing that due and lawful advertisement of the final hearing herein has been given by the posting of three certified copies of order in three public places and in the vicinity of said road which is proposed to be vacated and also by the posting of a certified copy of the Resolution of the court on the bulletin board at the West door of the County Court House in Pendleton, Oregon, being the place of holding the County Court, and for at least thirty days before the date set by the Court for the hearing and,

It appearing that due proof of the posting of said Notices is on file herein and that such affidavit is now before the Court, and the Court,

Finds that there are no remonstrance or objections on file to the vacating of County Road No 271 and No 429 in Township 4 South, Range 32, E. W. M. described particularly as follows:

Beginning at a point which point is approximately one quarter mile west of the quarter corners common to sections 19 and 20, Township 4 South, Range 32, E. W. M., thence east one half mile; thence South one mile to a point which point is approximately one quarter mile east of the quarter corners common to sections 29 & 30, Township 4 South, Range 32, E. W. M. That the legal description of the land adjacent to said road or part thereof and the names of the owners of said land is as follows:  $W\frac{1}{2}NE\frac{1}{4}$ , Millard F. Dick:  $E\frac{1}{2}NE\frac{1}{4}$ , Jas. P. Enright all in Sec. 19:  $SW\frac{1}{4}NW\frac{1}{4}$ ,  $W\frac{1}{2}SW\frac{1}{4}$   $NE\frac{1}{4}$   $SW\frac{1}{4}$ , A. M.

Kottmeier: SE $\frac{1}{2}$ SW $\frac{1}{4}$  Mary J. Pedro all in sec. 20: W $\frac{1}{2}$  NW $\frac{1}{4}$  A. M.  
 Kottmeier, E $\frac{1}{2}$ NW $\frac{1}{4}$  Mary J. Pedro all in section 29: All of the  
 above described land being in Township 4 South, Range 32, E. W. M.

And it appearing to the Court that the said Road or highway,  
 or that portion thereof which it is now proposed to vacate is  
 useless as a part of the general road system of Umatilla County,  
 Oregon, in that it is not used or needed by the general public,  
 or those living adjacent to said roadway.

It is therefore considered, ordered and adjudged that said  
 road be vacated as petitioned for and the same is hereby vacated.
