In the matter of a County Road
from a point in South line of Petition
S.W. ¹/₄ N.E. ¹/₄ Sec. 24 T4 S.R. 31 & com.
to Camas Creek near Cable

The undersigned citizens and house-
holders within Umatilla County, Oregon,
residing within the vicinity of the
hereinafter proposed County roads, do
herby respectfully pray the Honora-
ble County Court in and for Umatilla
County, Oregon, to lay out, locate,
open and establish a County road
within said County and State and upon the
following lines to wit. Commencing
at a point in the South line of the South
West quarter of the North East quarter of Section
Twenty four in township four South, of range
thirty one East of the Willamette meridian,
forty (40) rods West of the South East Corner
of the same and running thence East one ¹/₈
(1 ¹/₈) miles to North West Corner of the North East
quarter of the South West quarter of Section
Twenty in Township four South, of Range thirty
two East, thence South two (2) miles to

South West Corner of South East quarter
of North West quarter of Section thirty two in
said township and range, thence East three
quarters ($\frac{3}{4}$) of a mile to North East Corner of
North East quarter of South East quarter of
said Section township and range, thence
South three quarters ($\frac{3}{4}$) of a mile to South
East Corner of North East quarter of
North East quarter of Section five in
Township five South, in said range
last above mentioned, thence East one
quarter of a mile to the North East
Corner of the South West quarter of the
North West quarter of Section four in the
Township and range last mentioned
above. thence South one quarter of a mile
to South ^{East} Corner of the same, thence East
one quarter of a mile to North East Corner
of North East quarter of the South West quar-
ter of said Section township and range
thence in a southerly direction about
one half ($\frac{1}{2}$) of a mile on the most
practicable route to the most eligible
crossing of Camas Creek near the mouth
of Cade Creek, thence in a southerly direc-
tion on the most practicable route to a
point in the North line of Section nine
in said township and range last above

mentioned about, and not extending one fourth of a mile
thence East on the most practicable route
along or near said north line to the corner
of sections three (3) four (4) nine (9) and
ten (10) in the township and range last
above mentioned - and your petitioners
will ever pray &c;
