Report of Viewers, field notes and plat of Survey of bounty Road No 338 commencing at the intersection of the present bounty Road and Camas Creek S.W. corner of D.E. 1/4 of Section 4 T.P. 5 S.R. 32 E.W.M. thence following a South Easterly direction by the most practical route to the Section line between Sections 9 & 10 in said Township & Range thence South to the 1/4 mile stone between Sections 15 & 16 in the above named Township & Range thence South East to the North West corner of D.E. Clark's homestead thence South one half mile, thence South West to the 1/4 mile stone between Sections 21 & 22 in the above named Township & Range, thence South one half mile to the S.E. corner of Dec 21 T.P. 5 S.R. 32 E.W.M.

To the Hon County Court
Umatilla County, Oregon

We the undersigned, viewers on Road Survey No 338 would respectfully report that we met Jno C. Arnold Surveyor at the time and place appointed for the same and were each qualified according to law.

We called Edgar Thomson and S. M. McReynolds to chain and mark and D.E. Clark a man who were each duly qualified.

We viewed out and surveyed said Road 338 as specified in our order for the same and find the route to be very practicable and almost an absolute and imperative demand for a road operating as an outlet for the settlers in the vicinity of Road 338. Roads are few and trails have been opened and worked voluntarily so as to make them passable but the land over which they have been laid have subsequently been claimed and fenced and this means of travel practically ended.

We would therefore recommend that said road No 338 be declared a public highway.

Field Notes of Road Survey no 338 for Multnomah County Oregon.

I met full board of viewers on R 338 at time and place appointed for the same, and administer to each the usual form of oath. We call Edgar Thomson and D.E. Clark to chain and mark and L.M.M. Reynolds as assessor and qualify each according to law. I commence at a pt on R 241 on foot of steep grade on E side of Lewis Creek in SW 1/4 of D & 1/2 of Dec 4 & 5 O.R. 32 & and on var 200' - initial post 45' South of foot of grade and 110' E of Lewis Creek. I run from said initial post.

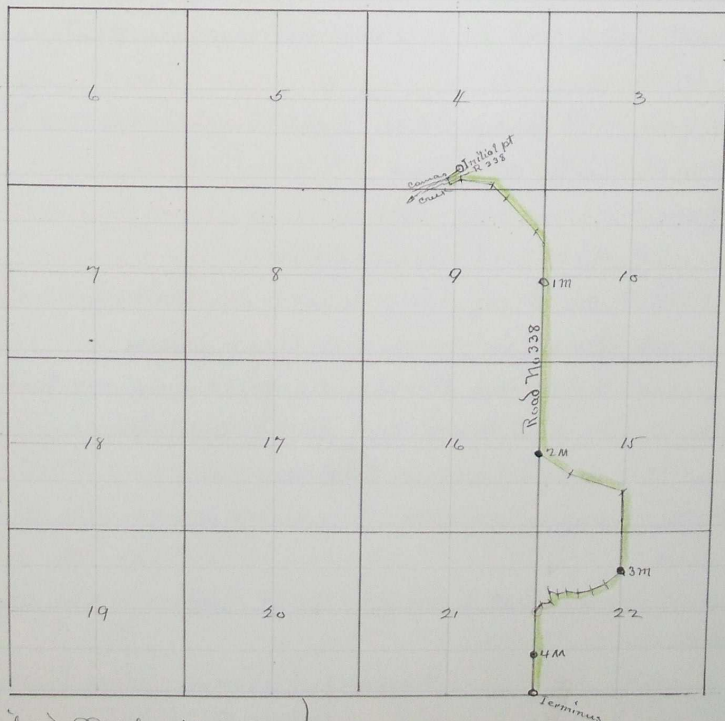
