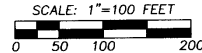


REPLAT FOR WEIDERT

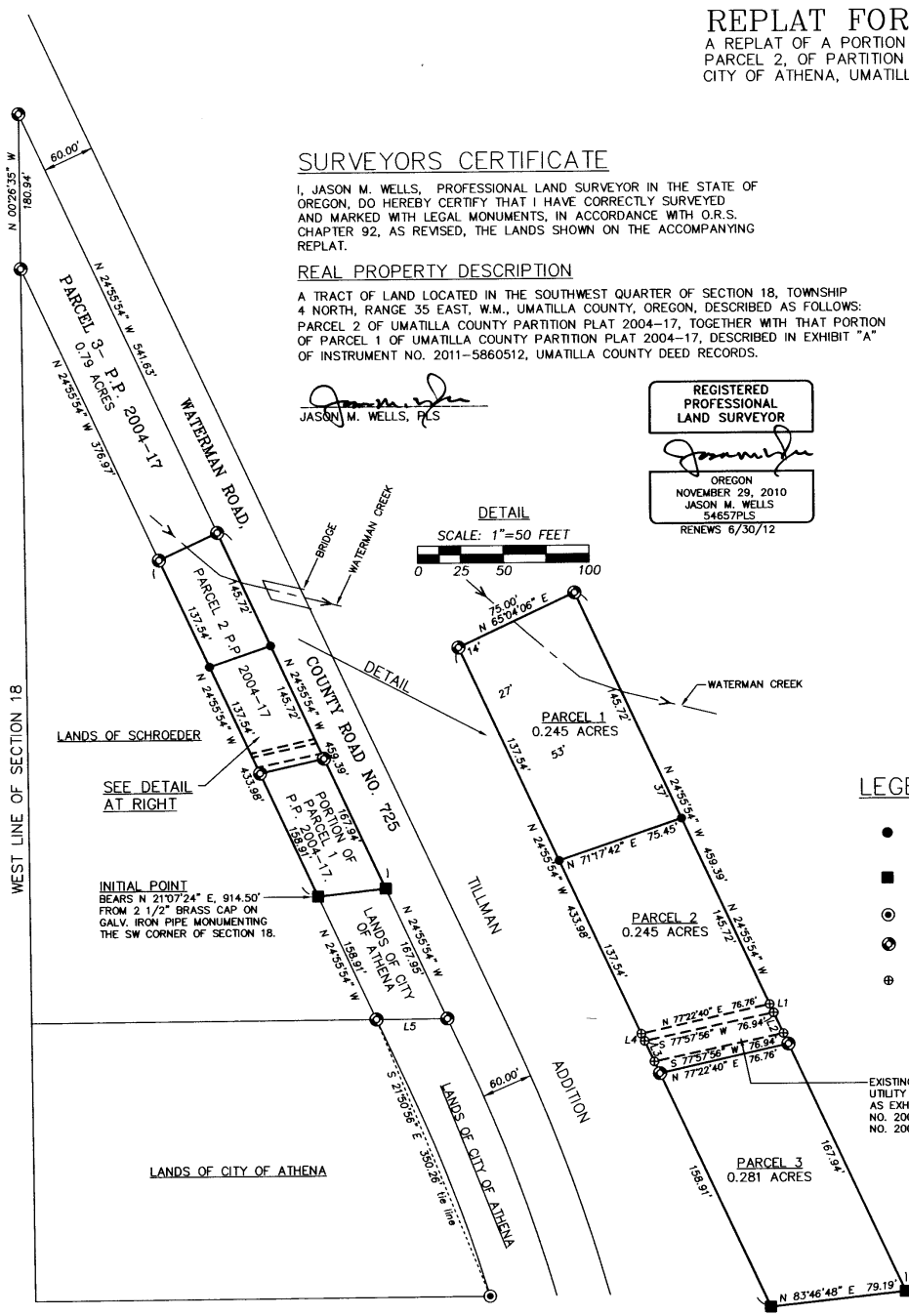
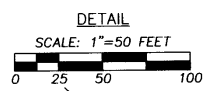
