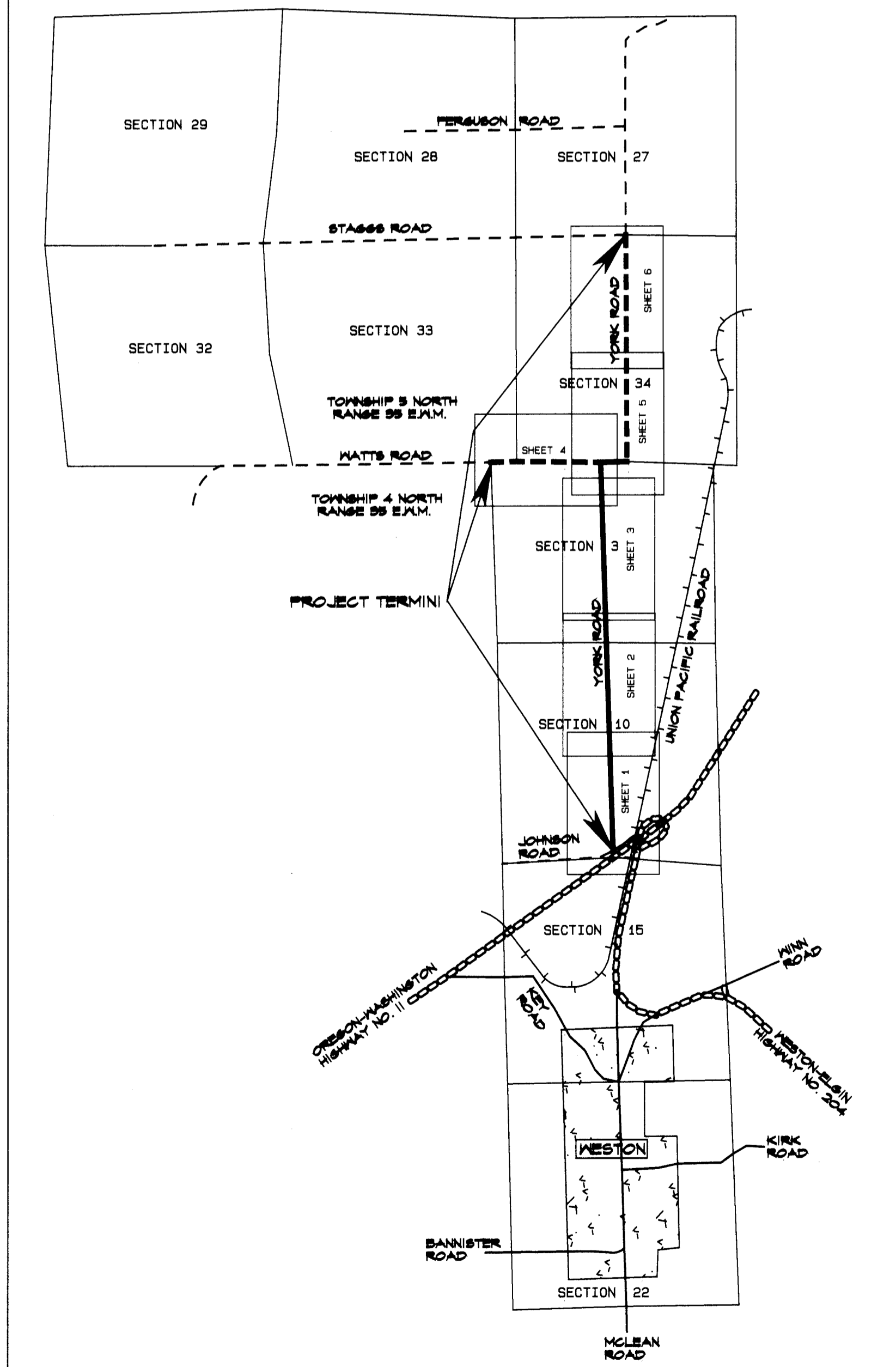

SURVEY NARRATIVE

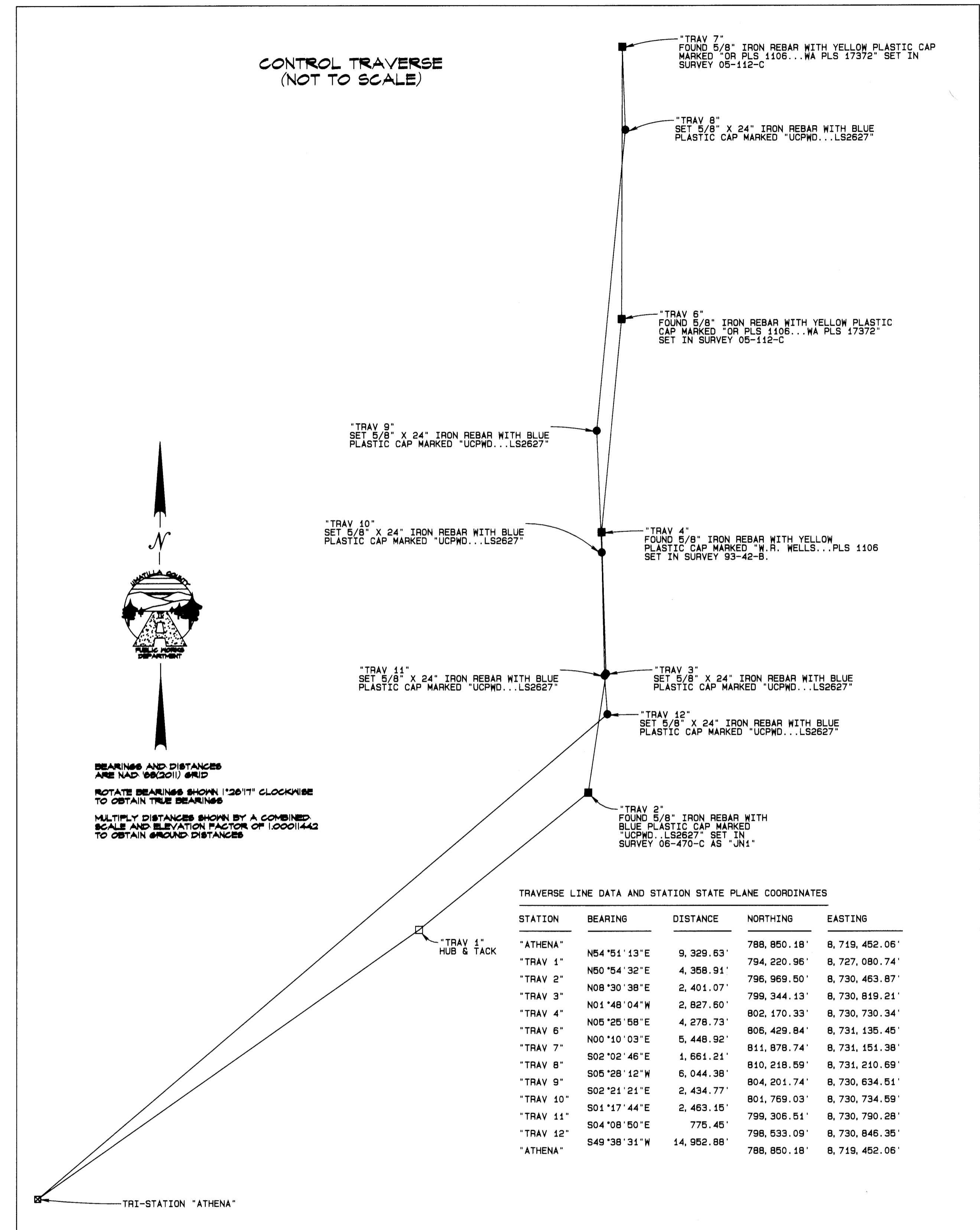
THE PURPOSE OF THIS SURVEY WAS TO MONUMENT AND DESCRIBE PORTIONS OF COUNTY ROAD NO. 647 (YORK ROAD), COUNTY ROAD NO. 667 (YORK ROAD), AND COUNTY ROAD NO. 676 (WATTS ROAD) FOR LEGALIZATION PURPOSES AFTER FINDING THAT THE LOCATION OF THE ROADS DO NOT NECESSARILY MATCH THE LOCATIONS DESCRIBED IN ORIGINAL ROAD RECORDS. IT IS ALSO APPARENT THAT CURVES WERE CONSTRUCTED WHERE SOUTH YORK ROAD TURNS EAST ONTO WATTS ROAD AND WHERE WATTS ROAD TURNS NORTH ONTO NORTH YORK ROAD (SEE 1930 MARKET ROAD NO. 43 PLAT) BUT NO EXTRA RIGHT-OF-WAY WAS ACQUIRED. CHOPIN WIND, L.L.C. IS IN THE PROCESS OF INSTALLING WIND TOWERS NORTHWEST OF THIS LOCATION AND NEEDS TO USE THE ROAD RIGHTS-OF-WAY TO INSTALL UNDERGROUND ELECTRIC LINES FROM THE TOWERS TO THE WESTON SUBSTATION. UMATILLA COUNTY NEEDS TO KNOW WHERE THESE RIGHTS-OF-WAY ARE FOR THE PERMITTING PROCESS.

COUNTY ROAD NO. 667, YORK ROAD, IS COMPRISED OF TWO OLD ROADS, ROAD NO. 15 AND ROAD NO. 43. A PORTION OF ROAD NO. 15 WAS ESTABLISHED ALONG THE NORTH-SOUTH CENTERLINE OF THE SOUTH 1/2 OF SECTION 10, TOWNSHIP 4 NORTH, RANGE 35 EAST IN 1871 AT A WIDTH OF 40 FEET TO A POINT APPROXIMATELY 1/4 MILE SOUTH OF THE CENTER OF SECTION 10 WHERE IT TURNED NORTHEASTERLY. IN 1876 ROAD NO. 43 WAS ESTABLISHED AT A WIDTH OF 60 FEET FROM A POINT 80 RODS SOUTH OF THE CENTER OF SECTION 10 NORTH TO THE TOWNSHIP LINE, EAST TO WHAT HAS BEEN ASSUMED TO BE THE SOUTH 1/4 CORNER OF SECTION 34 IN TOWNSHIP 5 NORTH, RANGE 35 EAST, THEN AGAIN NORTH THROUGH THE CENTER OF SECTION 34. PART OF COUNTY ROAD NO. 676 AND ALL OF COUNTY ROAD NO. 647 SHOWN IN THIS SURVEY ARE OLD ROAD NO. 43. THE PORTION OF COUNTY ROAD NO. 676 LYING WEST OF COUNTY ROAD NO. 667 WAS ORIGINALLY ESTABLISHED AS THE "ROAD FROM CRIGLER'S TO WESTON ROAD" (NO NUMBER) IN 1876 AT A WIDTH OF 60 FEET.

STATION "YORK SOUTH" 0+00.00 IS AT THE INTERSECTION OF THE PHYSICAL CENTERLINES OF JOHNSON ROAD TO THE WEST AND YORK ROAD TO THE NORTH. IT IS VERY CLOSE TO THE LOCATION OF THE SOUTH 1/4 CORNER OF SECTION 10 AS SHOWN ON O.S.H.D. RIGHT-OF-WAY MAP 88-10-25, WHICH SHOWS COUNTY ROADS LEADING NORTH, SOUTH, AND WEST FROM THE POINT. A 1900 RAILROAD MAP CLEARLY SHOWS THE 1/4 CORNER CENTERED ON A COUNTY ROAD TO THE SOUTH. THE 1927 RAILROAD MAP DOES NOT SHOW THE COUNTY ROADS, BUT THE TIE ANGLE AND DISTANCE FROM THE 1/4 CORNER TO THE TRACK CENTERLINE IS IDENTICAL WITH THE 1900 MAP. THE STATE OF OREGON ALSO USED THIS 1/4 CORNER LOCATION IN WRITING DEED DESCRIPTIONS FOR RIGHT-OF-WAY ACQUISITION FOR HIGHWAY 11. THIS LOCATION LIES N9°35'47"E, 96.92 FEET FROM THE MONUMENTED CORNER.

THE PROCEDURE USED IN THIS SURVEY WAS TO RUN A CLOSED RTK GPS TRAVERSE FROM TRI-STATION "ATHENA" THROUGH MONUMENTS FOUND OR SET IN THIS SURVEY TO THE NORTH END OF THE PROJECT AND THEN BACK (SEE CONTROL TRAVERSE DIAGRAM). SECTION MONUMENTS WERE THEN DOUBLE-TIED FROM THESE TRAVERSE POINTS. DATUM USED WAS NAD 83 (2011). THE AVERAGE SHIFT FROM THESE NAD 83 (2011) COORDINATES TO THE NAD 83 (91) COORDINATES PROVIDED BY BILL WELLS IN SURVEYS 05-12-C AND 05-112-C WAS S10°21'36"N, 0.33' AND WAS VERY CONSISTENT. MONUMENTS SET IN THIS SURVEY WERE POSITIONED SO THAT AT LEAST 2 OTHER FOUND OR SET MONUMENTS USED IN THE CONTROL TRAVERSE ARE VISIBLE FROM EACH ONE. EQUIPMENT USED IN THIS SURVEY WAS A LEICA VIVA RTK GPS SYSTEM.
