Corner was reestablished in Record of Private Surveys, Book 1, Page 484, by John Kimbrell in 1902. Kimbrell's record states "Set stone 22 x 5 x 10 for 1/4 Sec. Cor." Corner was recovered and noted as a 5" x 6" x 20" stone marked "1/4" on west face on Survey No. D-39-B

MONUMENT AND ACCESSORIES FOUND:

Found 37"x10"x7" stone set firmly in ground with top 12" above ground level marked 1/4 on west face. Stone is 6 feet North of and 8 feet East of a fence corner with fences North, South, East, and West.

MONUMENT SET:

At the position of the found set stone set a 1 1/4" x 30" galvanized iron pipe with 2 3/8" brass cap with top 6" above ground level. Placed original corner stone with marks facing up 1.5 feet South of brass cap monument and raised mound of earth to top of cap. Stamped cap as shown in monument marking detail.

A 5/8" x 24" iron rebar with yellow plastic cap stamped "OR PLS 1106, WA PLS 17372", bears North 05 1/2° West, 54.8 feet.

A 5/8" x 24" iron rebar with yellow plastic cap stamped "OR PLS 1106, WA PLS 17372", bears South 83° East, 68.1 feet.

A 5/8" x 24" iron rebar with yellow plastic cap stamped "OR PLS 1106, WA PLS 17372", bears South 72° East, 28.4 feet.

A $5/8" \times 24"$ iron rebar with yellow plastic cap stamped "OR PLS 1106, WA PLS 17372", bears South 14° West, 38.3 feet.

Attached bearing object signs to all rebar accessories and nailed witness sign to fence corner 8 feet West of monument.
