
PREVIOUS RENEWALS/SURVEYS ETC.

William Odell set a post, dug pits, raised mound, and scribed a single bearing tree (Contract No. 114, dated July 2, 1866).

In 1885, W. T. Chalk, County Surveyor, found the remains of Odell's bearing tree and set a stone marked 1/4 in a north-south lane.

MONUMENT SET (PROCEDURES AND DESCRIPTION): I held the line between a brass cap set by Steve Haddock found at the Northeast Corner of Section 22 and a 5/8" X 8" hex Corner of Section 22 and a 5/8" X 8" hex bolt found at the Southeast Corner of Section 22 for longitude and the east-west fence for latitude and monumented with a brass cap marked as shown above.

A 5/8" X 30" steel peper with blue plastic.

LOCATION AND COMMENTS:
The monument is set 6" below the surface of the edge of a dim road where the road crosses an east-west fence line approximately 1.1 miles north of State Highway 204.


