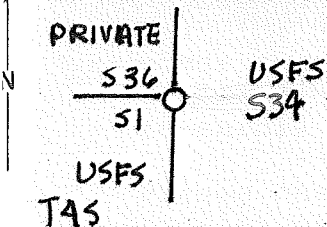

FROM THE SOUTH LINE OF 536 GO NORTH ON 2110-326 400 FT. TO AN UNMARKED ROAD THAT CONTINUES NORTHEASTERLY ½ MILE TO THE CREEK CROSSING. TAKE THE RIGHT FORK ACROSS THE CREEK, UP THE HILL A ¼ OF A MILE SOUTHEASTERLY, RIGHT AT THE NEXT FORK, ⅜ MILE OR SO, TO ANOTHER FORK, TURN RIGHT, GO THROUGH AN OPENING IN THE WOODS TO A CLEARING, FOLLOW ROAD SOUTHEASTERLY APPRX. ¼ MILE. TAKE LEFT FORK, GO EAST 350 FT TO CORNER

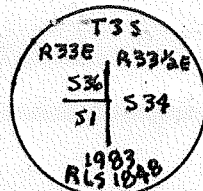

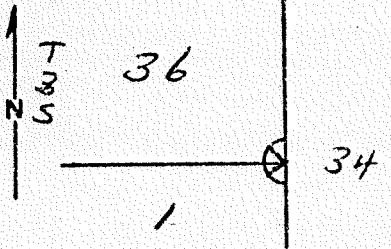
