A Berger transit reading to 30" of arc and standard steel tape were used.

True bearings were taken from observations on Polaris.

Section 3

Found rock accepted as original corner of sections 3, 4, 9 and 10.

Found pile of rocks which old inhabitants say were placed to perpetuate original corner of sections 3 and 4 on First Standard Parallel North.

Found rocks and post placed to perpetuate original corner of sections 2 and 3 on First Standard Parallel North.

Found rock with scribe marks placed to perpetuate the corner of sections 2, 3, 10 and 11.

The positions of above corners were accepted as being the same as the positions of the original corners.

The SW and NW corners of section 3 being intervisible from a point between, I set a hub at this point and ran due North along the west boundary of section 3.

20.00 Set trial 1/16 corner on line.

40.00 Found rock set to perpetuate  $\frac{1}{4}$  corner between sections 3 and 4.

83.48 NW cor. of sec. 3.

Above 1/16 cor. being in correct position, set 2 ins. x 4 ins. stake mkd. 1/16 on line as cor.

The NW cor. and the NE cor. of sec. 3 being intervisible from a point on line between, I set a hub at this point on line.

Ran

N.  $69^{\circ}38'$  W. on line bet. NW and NE cors. of sec. 3 from NE cor. along the N. Bdy. of sec. 3.

40.00 Set trial  $\frac{1}{4}$  cor.

80.61 NW cor. of sec. 3.

Set 2x4 ins. stake on line as  $\frac{1}{4}$  cor. 40.31 chs. from NE cor. of sec. 3.
