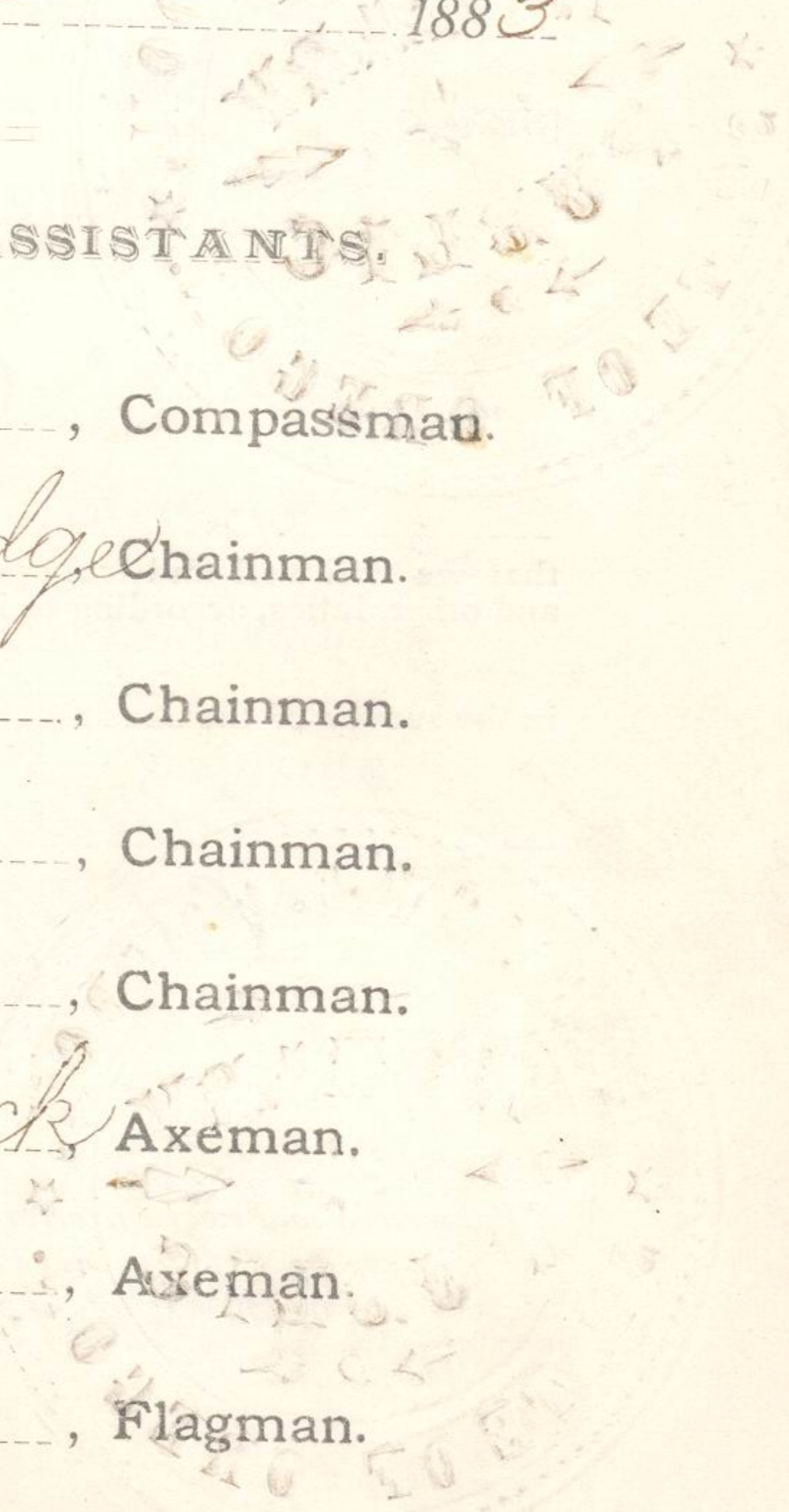

Preliminary to commencing this survey, I ran N. on a blank line on S. bdy. of sec. 36 and at 40.00 chs. found the $\frac{1}{4}$ sec. cor. and at 79.84 chs. found the sec. cor. As the E. boundary of sec. 36 was run by me, I do not rerun it.

Survey commenced May 4th 1883 with a Burt's improved Solar Compass. I commenced at the Stand. cor. to secs. 35 & 36 on the S. boundary of township, which is a stone 12 x 10 x 5 ins. set firmly in ground marked S.E. with 1 notch on E. and 5 notches on N. edges; from which a pine 12 ins. dia. br. N. 48° W. 41 kts. dist. marked T. 5 S R. 29 E.
