paid them, the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land 60 feet wide, being 30 feet on either side of the center line of said road, as surveyed over and across the NE 1/4 of the NE 1/4 and the SE 1/4 of the NE 1/4

and the NE 1/4 of the SE 1/4 and the SW 1/4 of the SE 1/4; all being in Section 8 of Twp. 3 North, Range 28 E.T.M. Beginning at a point on the said highway which point is known and designated as Station 125 / 12 of the Butter Creek Highway, Unit #3 survey, and which point is approximately 105 feet East and 1310 feet North of the 1/16 corner in the center of the NE 1/4 of Section 8 Twp 3 N. Range 28 E.T.M. thence S. 4° - 09' W. a distance of 902.1 feet; Thence on a 1° curve to the left 373.3 feet; thence S 0°-25' W. a distance of 39 feet to a point known and designated as 138 / 26.4 of the said survey which point is approximately 19 feet East of the 1/16 corner in the center of the NE 1/4 of Section 8 Twp 3 N. 28 E. T.M. Thence S 0°-25' West a distance of 2323.6 feet to a point known and designated as 151 / 50 of said survey which point is approximately 21.5 feet west of the 1/16 corner common to the NE 1/4 and the SE 1/4 of Sec 8, Twp 3 N. Range 28 E. T.M.; thence S. 0°-25' a distance of 573.7 feet; thence on a 2° curve to the right 944.2 feet; thence S 19° - 18' West a distance of 1256.1 feet to a point known and designated as Station 179 / 24 of the said survey, which point is 1981.7 feet West of the Section corner common to sections 8-9-16 & 17, Twp 3 N. Range 28 East T.M., said strip of land containing 7.46 acres, more or less.
