**In the Matter of Oregon Road,**

Known as the Echo-Butter Creek Highway

Know All Men by These Presents, That G. M. Madison, an unmarried man,

of the County of Umatilla, in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of One Dollar paid him, the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed, and by these presents do <sup>ss</sup> grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Thirty (30) feet wide, being Thirty (30) feet on the south side of the center line of said road, as surveyed over and across

The East half of Section 30, Township 3 North, Range 28 East, W. M. Said center line being more particularly described as follows: Beginning at the quarter corner common to Sections 29 and 30, thence in a westerly direction along the center line of said Section 30, one half mile more or less to the center of said Section 30, all in Township 3 North, Range 28 West, W. M. Contains 1.82 acres more or less.

Also a strip of land Sixty (60) feet wide being Thirty (30) feet on each side of the center line of said road as surveyed over and across the Southeast quarter of Section 30, Township 3 North, Range 28 East W. M. Said center line being more particularly described as follows: Beginning at Station 349 / 56.7 of the Echo-butter Creek Highway survey which Station is 3884.0 feet East of the Quarter corner on the West side of Section 30, Township 3 North, Range 28 East, W. M., thence on a 24 curve to the left, whose tangent at said point of beginning bears due west, a distance of 274 feet to a point known as Station 352 / 25 of the said survey. Said Station being 3830 feet West and 51 feet South of the Quarter corner on the West side of said Section 30. Contains 0.38 acres more or less.

To Have and to Hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
