

### In the Matter of Oregon Road

Known as the ECHO-BUTTER CREEK MARKET ROAD.

Know All Men by These Presents, That O. D. Teel, an unmarried man,

of the County of Umatilla,

in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of

paid to him, the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed, and by these presents do ca. grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit:

A strip of land 60 feet wide, being 30 feet wide on each side of the center line of the Echo-Butter Creek Market Road as surveyed over and across the South-west Quarter and the West Half of the Southeast Quarter of Section 17, Township 3 North, Range 29 East, W. H. The above mentioned center line being more particularly described as follows: Beginning at a point known and designated as Station 29 / 40.3, which point is 1495 feet South of the Northeast Corner of the Northwest Quarter of the Southeast Quarter of Section 17, thence South 65° 51' West, 872.4 feet, thence on a curve to the left, the radius of which is 5730 feet, a distance of 795.0 feet, thence South 57° 54' West, 2894.3 feet to a point known and designated as Station 67 / 05.7, a point on the Section line, 790 feet East of the Section Corner common to Sections 17, 18, 19 and 20, all in Township 3 North, Range 29, East, W. H.

To Have and to Hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.

The Grantee herein, as part of the consideration aforesaid, agrees to build a good and substantial three wire fence with cedar posts a rod apart on each side of the above described right of way and to place woven wire on the said fence across the irrigated land and to construct a stock crossing under the said road.
