have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet on each side of the center line of said road, as surveyed over and across

The east or half of Section 16 Township 2 North Range 32 East of W.M.

Beginning at a point on the quarter line between the E 1/4 and the W 1/4 of Section 16, T. 2 N. R. 32 EW. M. which point is approximately 1671.0 feet N. of the quarter section corner common to Sections 16 and 21, T. 2 N. R. 32 EWM running thence N. 48° 35' E. a distance of no feet, thence on a 1910.0 foot radius curve to the left a distance of 608.9 feet, thence N. 39° 40' E. a distance of 201.0 feet, thence on a 1146.0 radius curve to left a distance of 531.0 feet, thence N. 13° 07' E. a distance of 44.6 feet, which point is approximately 677.0 ft. N and 975 ft. e. of the 1/4 corner common to Sections 15 and 16 T. 2N. R. 32 EWM said parcel of land containing 5.29 acres more or less.

The above contains 0.53 acres within the right of way of the existing county road, and 2.76 acres to be acquired.
