paid To them, the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Seventy (70) feet wide, being Thirty-five (35) feet on each side of the center line of said road, as surveyed over and across

A portion of the North Half of Section 21 Township 2, North Range 32 East W.M.

Beginning at a point on the $\frac{1}{4}$ line between the $N\frac{1}{2}$ and the $S\frac{1}{2}$ of Sec. 21, T. 2 N.R. 32, E.W.M, which point is approximately 277.0 feet East of the center line of section 21, T. 2 N.R. 32, E.W.M running thence $18^{\circ} 04' W$, a distance of 1166.6 feet; thence on a 2865.0 foot radius curve to the right for a distance of 311.9 feet; to a point of ending, which point is approximately 1208 feet south and 120 feet west of the quarter section corner common to Sec. 16 and 21, T. 2 N. R. 32 E.W.M.

The above contains 0.52 acres within the right of way of the existing county road and 1.89 acres to be acquired.
